



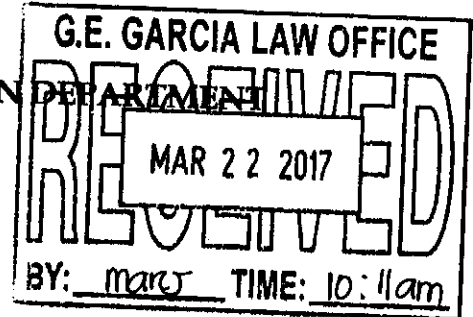

MARCH 17, 2017**

The meeting started at 8:35 in the morning presided by the undersigned Election Officer of Toledo City.

The following are present during the meeting:

The undersigned discussed the parties and their respective counsels the guidelines of his directive dated 16 March 2017 re Implementation of the Commission's Order (Second Division).

The Protestant of the instant case reiterated and informed the undersigned and those who were present that the schedule of departure from Cebu to Manila which was originally on March 17, 2017 at 9:00 o'clock in the morning was postponed to March 18, 2017 at 6:00 o'clock in the morning.

At around 11:35 in the morning, the City Treasurer turned-over twenty (20) contested ballot bins and eight (8) black cartoon boxes of Official Ballot box outside the bin, properly sealed with signatures of all the parties present and/or their authorized representatives.

There were no more topics to be discussed, the meeting was temporarily adjourned at 12:15 in the afternoon for a lunch break.

Minutes in the retrieval, identification, checking, resealing of contested ballot boxes, and transmittal.

March 17, 2017

All members convened at 8:35 am at the Comelec, Toledo Office, discussing the plan for the retrieval of contested ballot boxes. After the discussion everybody proceed to the Arcade Bldg. located at the Toledo Commercial Village for the retrieval of the ballots. The three (3) storage rooms were located and the official opening of the first storage room started at 9:05 am in the presence of all concerned parties (see attached attendance sheet), watchers, and the treasury personnel who were tasked to do the manual lifting, identifying the ballot boxes and gathering datas. At 9:25 the first room was emptied and six (6) ballot boxes were identified as included in the contested list. The second storage room was opened at 9:30 am and another five (5) ballots were identified as included in the list. The second room was emptied at 9:40 am. All the black boxes which were included and identified in the list were taken out from storage room no. 3. The third and last storage room was opened at 9:45 am and after some careful checking the remaining ballot boxes in the list were pulled out. At 9:55 am all the boxes were out and as announced by Mr. Rivera, the City Treasurer, the remaining ballot boxes which were not included in the contested list were stored again inside the storage rooms and it was officially closed at 10:24 am.

The checking, re-sealing and signing the seals were made by the parties concerned in every ballot box. The same procedure were made with the black boxes, all were re-sealed, sign and tied, and the eight (8) black boxes were tied by four. The following were the black boxes that contains the receipts of the official ballots, the one mentioned in the transmittal and it's description.

All the ballot boxes were then taken down and deposited inside the waiting container van at 11:35 am, the van was then closed and locked. In the presence of all the parties concerned and the treasury personnel, PNP personnel and the Comelec.






When everything seemed done it was found out that there were two (2) black boxes inadvertently included inside the container van, it was then returned back to the Treasury personnel and put inside the storage room no. 2, with labels CP 142 Talavera and CP 41 Cambang-ug, respectively.
