Protestant **FERDINAND "BONGBONG" R. MARCOS, JR.**  
("protestant Marcos"), through the undersigned counsels, unto this  
Honorable Presidential Electoral Tribunal ("PET"), most respectfully  
states that:

**1.** On **18 October 2017**, protestant Marcos paid the  
Commission on Elections (COMELEC) the amount of **Two Million  
Nine Hundred Seventy Four Thousand Seventy Five Pesos  
(Php2,974,075.00)** representing the costs and expenses for the  
conduct of the decryption and printing of the ballot images, election  
returns and audit logs for **ALL** the protested clustered precincts of  
the pilot provinces of Camarines Sur, Iloilo and Negros Oriental used  
during the last 9 May 2016 National and Local elections. A copy of  
the official receipt is herein attached for your convenient reference.

**2.** Meanwhile, the supplies required by the Election Records  
and Statistics Department (ERSD) of the COMELEC were also  
delivered by protestant Marcos on **20 October 2017**.

**3.** According to the *Manifestation* dated **7 October 2017**, the  
COMELEC shall proceed with the decryption and printing of the ballot

images, election returns and audit logs for **ALL** the protested clustered precincts of the pilot provinces of Camarines Sur, Iloilo and Negros Oriental at the Project Management Office (PMO) of the COMELEC on **23 October 2017** at **9:00 a.m.** until termination thereof.






