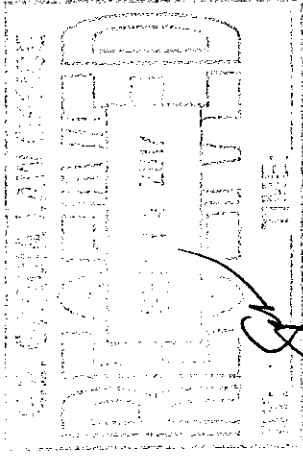
(a) **NOTE** the Counter-Manifestation (to the Manifestation dated August 7, 2017), dated August 22, 2017 filed by counsel for protestant Ferdinand ‘Bongbong’ R. Marcos, Jr.; and

(b) **NOTE** the Letter dated August 29, 2017 of Atty. Jose M. Tolentino, Jr., Executive Director, Commission on Elections (COMELEC), relative to the Letter dated July 21, 2017 of Deputy Executive Secretary Rizalina N. Justol of the Finance and Administration Office, Office of the President (OP), concerning the immediate turn-over of the office units which are currently being occupied by the COMELEC at the Ground Floor, Palacio del Gobernador Building (Quadrants ‘B’ and ‘D’) for use by the newly-created offices of the OP; and **GRANT** Atty. Tolentino, Jr.’s request for authority to transfer the election documents and Secure Digital (SD) cards relative to the May 9, 2016 National and Local Elections, presently stored at the aforementioned office units, to a location within the COMELEC premises, subject to the following conditions:

- (i) The COMELEC shall give the Tribunal and the parties prior notice of the date/s of the transfer; and
