*Please take notice that the Tribunal issued a Resolution dated **OCTOBER 3, 2017**, which reads as follows:*

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to

(a) **GRANT** the Motion dated September 25, 2017 filed by the Office of the Solicitor General for the Commission on Elections (COMELEC) for a second extension of ten (10) days from September 26, 2017, or until October 6, 2017, within which to comply with the show cause order in the resolution dated August 29, 2017;

(b) **NOTE** and **GRANT** the Letter dated September 23, 2017 of Atty. Jose M. Tolentino, Jr., Executive Director, COMELEC, seeking approval of the request of Flor Evangeline C. Japitan, Acting Election Officer, R.T. Romualdez, Agusan del Norte, for authority to transfer, among other things, the book of voters used in the 2016 National and Local Elections, as the Office of the Election Officer of the said Municipality shall likewise be transferred from its present location to another building located within the Municipal Compound;

(c) **NOTE** the Letter dated September 25, 2017 of Atty. Tolentino, Jr., submitting a copy of the Minutes submitted by Nonnato M. Mabutas, Election Officer III, and Manuela DJ. Salazar, Municipal Treasurer, both of Balayan, Batangas, on the transfer conducted on September 11, 2017 of the contents of the ballot boxes used during the May 9, 2016 National and Local Elections that were damaged by the earthquake that occurred last April 8, 2017 to the metal ballot boxes that are utilized under a manual election system, in accordance with the authority given by the Tribunal in the resolution dated July 25, 2017;


(d) **NOTE** the Letter dated September 27, 2017 of Atty. Tolentino, Jr., forwarding the Memorandum dated September 8, 2017 of Atty. Ramon J. Dadulla, Jr., Election

Officer, Ormoc City, relative to the transfer of ballot boxes used in the 2010, 2013 and 2016 Elections from the lobby of the Ormoc City Hall to a room on the ground floor of the Ormoc City Hospital Building in Brgy. San Pablo, Ormoc City; and

(e) **NOTE** and **GRANT** the Letter dated September 27, 2017 of Atty. Girlie I. Salarda, Secretary of the Senate Electoral Tribunal, stating that the House of Representatives Electoral Tribunal (HRET) was granted temporary prior custody of the ballot boxes involved in the election protest cases pending before it, except for one case; and requesting for authority or clearance to decrypt and print the picture images of the ballots in the said cases, including those involved in HRET Case No. 16-024 (EP) (Papin vs. Fuentebella, 4th District, Camarines Sur)."
