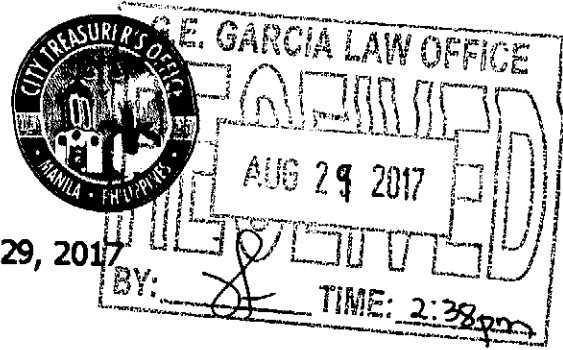


Greetings !

Please take notice that the Tribunal issued a Resolution dated JULY 25, 2017, which reads as follows:

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to

(a) **NOTE** and **GRANT** the following letter-requests, subject to the conditions that the (1) Commission on Elections (COMELEC) shall give the Tribunal and the parties prior notice of the activities and (2) parties shall be allowed to observe and participate therein:

(i) Letter dated May 26, 2017 of Atty. Jose M. Tolentino, Jr., Executive Director, COMELEC, seeking approval of the request of Fredelyn J. Lapitan, Municipal Treasurer of Lian, Batangas, to transfer the ballot boxes used in the May 9, 2016 National and Local Elections to another stockroom located in the same building;

(ii) Letter dated May 29, 2017 of Atty. Tolentino, Jr., seeking approval of the request of Jose R. Bascon, Election Officer, Balingasag, Misamis Oriental, to open the ballot box of Clustered Precinct No. 65 (Precincts Nos. 0109A, 0109B & 0109C) of Barangay Talusan, said Municipality, used in connection with the May 9, 2016 National and Local Elections, to retrieve the SD Card inadvertently placed inside the said ballot box by the Board of Election Inspectors;

(iii) Letter dated May 30, 2017 of Atty. Tolentino, Jr., seeking approval of the request of Nonnato M. Mabutas, Election Officer III, Balayan, Batangas, to open the ballot boxes used in the May 9, 2016 National and Local Elections that were damaged by the earthquake of April 8, 2017 and to transfer the ballots contained therein to the metal ballot boxes that are utilized under a manual election system; and



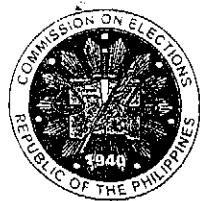

Greetings !

This pertains to your letter dated 07 July 2017 requesting to transfer the 3,133 bins and 4,670 serviceable metal boxes to 4th Floor of police Station, 11 Building, La Chambre corner San Felipe Sts., Binondo, Manila, every weekend from July 15 2017 to 13 August 2017. Undersigned endorsed your letter to the Office of Director J. Thaddeus P. Hernan, *Administrative Services Department (ASD)* which subsequently endorsed by his office to the Office of the Executive Director for approval.

In this regard, please be informed that per attached Memorandum of Executive Director Jose M. Tolentino, Jr. dated 19 July 2017, authority for the transfer of the 2016 ballot boxes, consisting of at least two-hundred twenty-four (224) units which are subject of the Precautionary Protective Order (PPO) in PET Case No. 005, *Ferdinand R. Marcos, Jr. vs. Ma. Leonor G. Robredo*, has been requested from the Presidential Electoral Tribunal (PET).

With regard to the remaining ballot boxes and bins, Executive Director Tolentino has authorized the transfer of the same provided that the following shall be observed:

1. The Election Officer/Assistants/representative to make ocular inspection of the proposed new storage area, to ensure that it is conducive for the security and protection of the ballot boxes, so as to prevent further deterioration of the boxes;
2. The Election Officer/Assistant/representative to undertake recording of the details of the boxes transferred, noting the precinct/clustered


precinct number, barangay, district and the election/s in which it was used before these are moved out of the old storage area, after its arrival at the new storage area; and

3. The Election Officer/Assistants/representative shall accompany the movers to ensure that no untoward incident occurs.

Please coordinate with the Election Officers of Manila on the said transfer of ballot boxes and bins.

Please be guided accordingly. Thank you.
