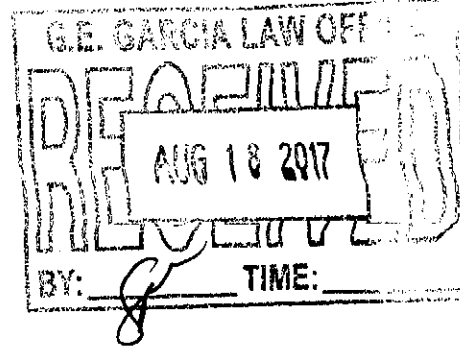

*Please take notice that the Tribunal issued a Resolution dated JULY 25, 2017, which reads as follows:*

**"P.E.T. Case No. 005** (Ferdinand 'Bongbong' R. Marcos, Jr. vs. Maria Leonor 'Leni Daang Matuwid' G. Robredo).- The Tribunal Resolved to

(a) **NOTE** and **GRANT** the following letter-requests, subject to the conditions that the (1) Commission on Elections (COMELEC) shall give the Tribunal and the parties prior notice of the activities and (2) parties shall be allowed to observe and participate therein:

(i) Letter dated May 26, 2017 of Atty. Jose M. Tolentino, Jr., Executive Director, COMELEC, seeking approval of the request of Fredelyn J. Lapitan, Municipal Treasurer of Lian, Batangas, to transfer the ballot boxes used in the May 9, 2016 National and Local Elections to another stockroom located in the same building;

(ii) Letter dated May 29, 2017 of Atty. Tolentino, Jr., seeking approval of the request of Jose R. Bascon, Election Officer, Balingasag, Misamis Oriental, to open the ballot box of Clustered Precinct No. 65 (Precincts Nos. 0109A, 0109B & 0109C) of Barangay Talusan, said Municipality, used in connection with the May 9, 2016 National and Local Elections, to retrieve the SD Card inadvertently placed inside the said ballot box by the Board of Election Inspectors;

(iii) Letter dated May 30, 2017 of Atty. Tolentino, Jr., seeking approval of the request of Nonnato M. Mabutas, Election Officer III, Balayan, Batangas, to open the ballot boxes used in the May 9, 2016 National and Local Elections that were damaged by the earthquake of April 8, 2017 and to transfer the ballots contained therein to the metal ballot boxes that are utilized under a manual election system; and

(iv) Letter dated June 20, 2017 of Atty. Tolentino, Jr., seeking approval of the request of

Luningning A. Ravina, Election Officer III, San Antonio, Quezon, for authority to open the ballot boxes used in the May 9, 2016 National and Local Elections to determine their clustered precinct numbers;

(b) **NOTE** and **GRANT** the following letter-requests:

Talegon, Assistant City Treasurer-OIC, City of Manila, for authority to transfer the ballot boxes used in the May 9, 2016 National and Local Elections to the 4<sup>th</sup> Floor of the Police Station, 11 Building, La Chambre cor. San Felipe Streets, Binondo, Manila, starting July 15, 2017 to August 13, 2017; and

(c) **NOTE** the Manifestation and Comment of Protestee Maria Leonor G. Robredo on the Preliminary Conference Guide dated July 18, 2017 filed by counsel for protestee Robredo in compliance with the Tribunal's directive during the Preliminary Conference on July 11, 2017. (1)
