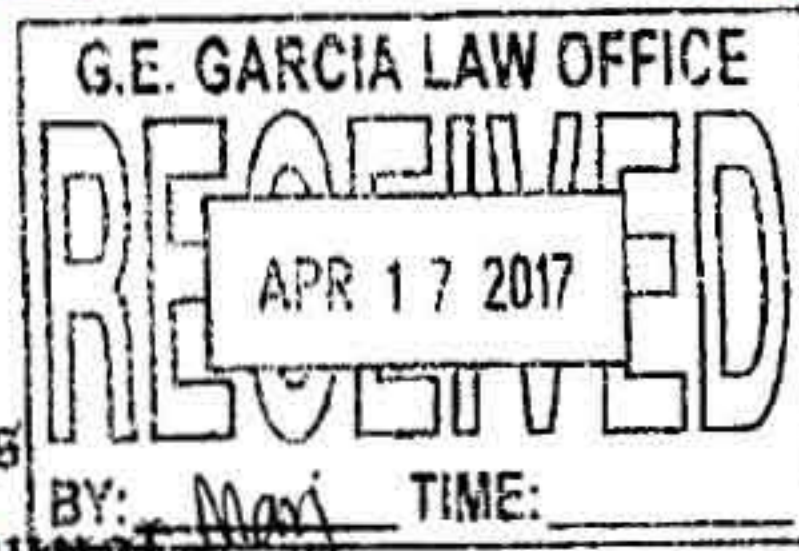

Sirs/Mesdames:

*Please take notice that the Tribunal issued a Resolution dated **APRIL 4, 2017**, which reads as follows:*

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- **P.E.T. Case No. 005** (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to

(a) **NOTE** and **GRANT** the following letters of Jose M. Tolentino, Jr., Executive Director, Office of the Executive Director, COMELEC, *subject to the condition* that the Commission on Elections (COMELEC) shall (i) give the Tribunal and the parties prior notice of the date of opening of the ballot boxes and retrieval of the election return copy of the COMELEC; and (ii) inform the Tribunal and the parties of the status and result of the said activities, to wit:

(1) Letter dated January 5, 2017 seeking approval of the request of Leonardo G. Dizon, Jr., Election Officer IV, Baybay City, Leyte, for authority to open the ballot box of Clustered Precinct No. 33 to retrieve the Election Return for the May 9, 2016 National and Local Elections which was inadvertently placed therein by the Board of Election Inspectors;

(2) Letter dated January 10, 2017, seeking approval of the request of Atty. Ramon B. Rosello, Election Officer IV, Muntinlupa City, for authority to open the ballot box of Clustered Precinct No. 380 of Barangay 172 to retrieve the Election Return Copy of the COMELEC which was inadvertently deposited therein by the Board of Election Inspectors for the said clustered precinct; and

(3) Letter dated January 11, 2017, seeking approval of the request of Phoebe R. Narrazid, Election Officer III, Bataraza, Palawan,



for authority to open the ballot boxes of Precinct Nos. 4, 5, 27, 34 and 39 to retrieve the Election Returns for the May 9, 2016 National and Local Elections which were inadvertently placed therein by the Board of Election Inspectors;

(b) **NOTE** and **GRANT** the Letter dated February 13, 2017 of Efren E. Pascual, Jr., Municipal Mayor, Orani, Bataan, requesting approval of their request to transfer the approximately 147 ballot boxes used during the May 2016 National and Local Elections from the Multi-Purpose Gymnasium to the 3rd Floor of their Municipal Building, *subject to the condition* that Mayor Pascual, Jr. shall (i) give the Tribunal and the parties prior notice of the date of the transfer of the 147 ballot boxes; and (ii) inform the Tribunal and the parties of the status and result of the foregoing activities; and

(c) **NOTE** the Letter dated March 20, 2017 of Ester L. Villaflor-Roxas, Director IV, Election Records and Statistics Department (ERSD), COMELEC, relative to the resolution dated March 7, 2017, stating that the ERSD already conducted the decryption of the Secure Digital (SD) cards, election returns and audit logs from February 15 to 18, 2017 per Order of the Regional Trial Court (RTC), Branch 63, Calabanga, Camarines Sur in EPC No. 16-008 and that the documents/results pertaining to the said case were already turned over to the Clerk of Court of the RTC, Branch 42, Calabanga, Camarines Sur; and suggesting that the request of protestant Ferdinand R. Marcos, Jr. be addressed directly to the said RTC considering that it has in its possession the decrypted files (ballot images, election returns, audit logs and statistical data) and the same were already deleted from the ERSD files." 
