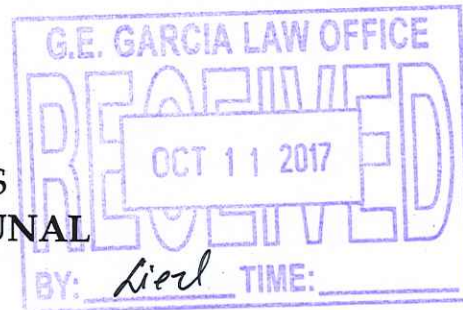

MANIFESTATION

The Commission on Elections (COMELEC), through the undersigned counsels of the Law Department, and unto this Honorable Tribunal, most respectfully states:

1. On 05 September 2017, the COMELEC received this Honorable Tribunal's Resolution dated 29 August 2017 directing it, among others, to **inform** the Honorable Tribunal of its recommended procedures, logistics, schedule and estimated costs for the Decryption and Printing of Ballot Images insofar as all the precincts in the provinces of Camarines Sur, Iloilo and Negros Oriental are concerned, within a non-extendible period of ten (10) days from receipt of Resolution;

2. In Compliance thereto, the COMELEC, through the Office of the Solicitor General (OSG), filed a Manifestation/Compliance with Motion dated 14 September 2017, stating among others, that as to the schedule of decryption, the COMELEC, will abide by this Honorable Tribunal's preferred date for the conduct of the decryption and printing of ballot images.

3. The same was NOTED by this Honorable Tribunal's Resolution dated 19 September 2017.

4. Thus, this *Manifestation* is being filed to respectfully inform this Honorable Tribunal and the parties in this case that the schedule of the decryption and printing of ballot images, audit logs and election returns for all the precincts in the provinces of Camarines Sur, Iloilo and Negros Oriental, shall commence on **23 October 2017 (Monday) at 9:00 A.M until termination thereof**, at the **Project Management Office (PMO), COMELEC, Ground Floor, Palacio Del Gobernador, Intramuros, Manila** per Memorandum dated 6 October 2017¹ prepared by Director Ester L. VillaflorRoxas, Election Records and Statistics Department (ERSD), COMELEC.

PRAYER

WHEREFORE, premises considered, the Commission on Elections prays that the schedule of the decryption and printing of ballot images for all the precincts in the provinces of Camarines Sur, Iloilo and Negros Oriental commencing on **23 October 2017 (Monday) at 9:00 A.M until termination thereof** at the **Project Management Office, Commission on Elections, Ground Floor, Palacio Del Gobernador, Intramuros, Manila** be **APPROVED** by the Honorable Presidential Electoral Tribunal, and that the parties be notified accordingly.


Other reliefs just and equitable under the premises are likewise most respectfully prayed for.

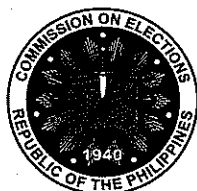
