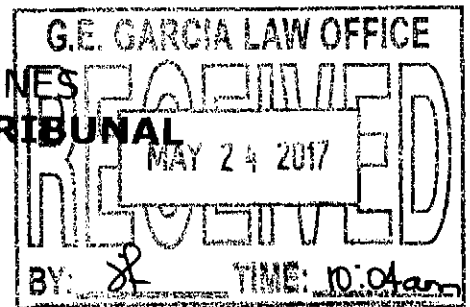

[Re: Compliance with Resolution dated 18 April 2017
and Resolution dated 25 April 2017]

The **COMMISSION ON ELECTIONS**, through the **OFFICE OF THE SOLICITOR GENERAL**, and unto this Honorable Tribunal, respectfully states:

1. On 5 May 2017, the COMELEC, through the OSG, filed a *Motion for Additional Time* of even date asking this Honorable Tribunal for fifteen (15) days from 6 May 2017, or until 21 May 2017, within which to fully comply with this Honorable Tribunal's Resolutions dated 18 April 2017 and 25 April 2017.

2. A draft of the Manifestation/Compliance is already being prepared. The OSG, however, is still awaiting transmittal from the COMELEC of certain documents that are relevant to the matters required to be manifested by this Honorable Tribunal. Further, the draft of the Manifestation/Compliance will still have to undergo review by the concerned officers and employees from the COMELEC, as well as internal review by the OSG.
