Dear **Hon. Sereno**:

This has reference to the Resolution dated February 14, 2017 of the Honorable Presidential Electoral Tribunal in P.E.T. Case No. 005 (*Ferdinand "Bongbong" R. Marcos, Jr. vs. Maria Leonor "Leni Daang Matuwid" G. Robredo*), resolving, among others to:

- (b) *ALLOW protestee Robredo to secure copies of the printed ballot images, election returns and audit logs from the Municipality of Siruma, Camarines Sur only, subject to payment of the appropriate Fees; and*
- (c) *ADVISE protestee Robredo to coordinate with the COMELEC on this matter.*

A propos the above Resolution, please be advised that when it was received by this office on February 21, 2017, the decryption of SD cards, election returns and audit logs per Order by the Regional Trial Court, Branch 63, Calabanga, Camarines Sur, conducted by this Department, was already terminated on February 18, 2017, and the documents/results pertaining to said case were already turned over to the RTC Clerk of Court of Branch 42.

In this regard, it is hereby suggested that the request of protestee Robredo be addressed now to the RTC, with permission or request for authority from the PET, considering that presently, the said Court has in possession of the decrypted files (ballot images, election returns, audit logs and statistical data), and the same were already deleted from our files.

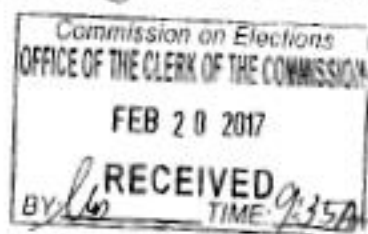
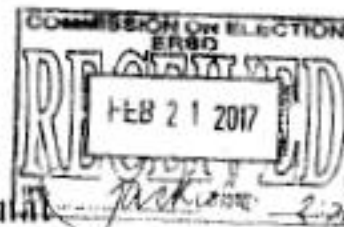

"P.E.T. Case No. 005 (Ferdinand 'Bongbong' R. Marcos, Jr. vs. Maria Leonor 'Leni Daang Matuwid' G. Robredo).- The Tribunal Resolved to

(a) **NOTE** the Letter dated January 31, 2017 of Atty. John Gerald B. Dela Cruz, Division Clerk, First Division, Commission on Elections (COMELEC), furnishing the Tribunal with certified true copies of the Orders issued by the COMELEC First Division after the October 5, 2016 resolution of the Tribunal to inform the Tribunal of the actions taken regarding the ballots and other election documents/paraphernalia pertaining to the protested and/or counter-protested precincts involved in EPC 2016-21 (Sheila Y. Saratan vs. Nilo Jesus Antonio Neil E. Lizares III) and EPC 2016-31 (Omar 'Solitario' M. Ali vs. Majul U. Gandamra); and

(b) **NOTE** the Letter dated January 31, 2017 of Ester L. Villaflores-Roxas, Director IV, Election Records and Statistics Department, COMELEC, informing the Tribunal that the decryption of the Secure Digital (SD) Cards and printing of ballot images, election returns and audit logs for the 25 clustered precincts of the Municipality of Siruma, Camarines Sur, used during the May 9, 2016 National and Local Elections, is scheduled on February 15, 2017, 9:00 A.M. until completion, at the COMELEC-Project Management Office, Ground Floor, Palacio Del Gobernador, Intramuros, Manila.


