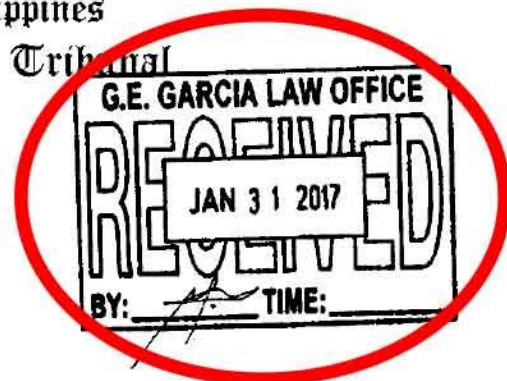

*Please take notice that the Tribunal issued a Resolution dated JANUARY 17, 2017, which reads as follows:*

**“P.E.T. Case No. 005** (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to

(a) **NOTE** and **GRANT** the Letter dated December 23, 2016 of Atty. Manuel P. Teoxon, counsel for the protestee/counter-protestant Sandy Ondis in Election Protest Case No. 16-008, No. 18 Caimito Street, Dayangdang, Naga City, requesting that the Election Records and Statistics Department-Commission on Elections (ERSD-COMELEC) be authorized and allowed to decrypt the SD Cards and print the digital ballot images, Election Returns and Audit Logs for the 25 protested clustered precincts used during the May 9, 2016 Local Election at the Municipality of Siruma, Camarines Sur (Bicol Region), in compliance with the Order dated December 12, 2016 issued by Judge Pedro M. Redona, Regional Trial Court (RTC), Branch 63, Calabanga, Camarines Sur;

(b) **DIRECT** the ERSD-COMELEC to **INFORM** the Tribunal and the parties of the schedule and status of the decryption;

(c) **NOTE** the Letter dated January 12, 2017 of Gary Louie S. Comia, Computer Programmer II, and Anthony C. Lumansoc, Computer Operator I, Management Information Systems Office, relative to the post-election VCM (Vote Counting Machine) Reverse Stripping at the COMELEC Warehouse in Sta. Rosa, Laguna, where personnel from the said office participated as observers;

(d) **NOTE** the Letter dated November 10, 2016 of Helen G. Aguila-Flores, Deputy Executive Director for Administration, Office of the Executive Director, COMELEC, seeking confirmation of the delivery of the ballot boxes to the RTC, Branch 19, Isulan, Sultan Kudarat, for election cases filed therein in connection with the May 9, 2016 National and Local


January 17, 2017

Elections, which were delivered before the issuance of the Precautionary Protection Order;

(e) **REQUIRE** RTC, Branch 19, Isulan, Sultan Kudarat to **CONFIRM** its receipt of the aforesaid ballot boxes within ten (10) days from notice hereof; and

(f) **NOTE** and **GRANT** the Letter dated January 13, 2017 of Michael L. Garcia, Acting Division Clerk, Second Division, COMELEC, reiterating the request in his Letter dated December 22, 2016 and, in addition, requesting for the same authority to be granted with respect to Clustered Precinct No. 743, consisting of Precinct Nos. 1814B, 1815B, 1816A and 1817A in Barangay Quiot Pardo, Cebu City, Province of Cebu.
