*Please take notice that the Tribunal issued a Resolution dated NOVEMBER 22, 2016, which reads as follows:*

**"P.E.T. Case No. 005** (Ferdinand 'Bongbong' R. Marcos, Jr. vs. Maria Leonor 'Leni Daang Matuwid' G. Robredo).- The Tribunal Resolved to

(a) **NOTE** and **GRANT** the Letter dated November 15, 2016 of Atty. Michael L. Garcia, Acting Division Clerk, Second Division, Commission on Elections (COMELEC), requesting authority for the temporary prior custody of the ballot boxes and the contents thereof, recount of ballots, other election documents or paraphernalia, including the list of voters such as the Election Day Computerized Voter's List (EDCVL), Voter's Registration Records (VRR) and Book of Voters (BOV), as well as the data storage devices used in the May 9, 2016 Elections for the position of Mayor of San Juan City in the therein mentioned clustered precincts relative to EPC No. 2016-05 (Francisco Javier M. Zamora vs. Guia G. Gomez);

(b) **NOTE** and **GRANT** the Letter dated November 15, 2016 of Atty. Garcia, requesting authority for the temporary prior custody of the ballot boxes and the contents thereof, recount of ballots, other election documents or paraphernalia, including the list of voters such as the Election Day Computerized Voter's List (EDCVL), Voter's Registration Records (VRR) and Book of Voters (BOV), as well as the data storage devices used in the May 9, 2016 Elections for the position of City Councilor, Toledo City, Cebu, in the therein mentioned clustered precincts relative to EPC No. 2016-07 (Ma. Risa Rafols Angana vs. Arlene Espinosa Zambo, et al.);

(c) **GRANT** the Urgent *Ex-Parte* Motion for Leave to be Allowed to Decrypt the Set Aside Secure Digital Cards and Printing of the Audit Logs dated November 15, 2016 filed by counsel for protestee Robredo, praying that an order be issued allowing the decryption of the Secure Digital (SD) cards set aside during the stripping activities and the printing of the

audit log reports together with other relevant data that may be contained therein;

(d) **DIRECT** the COMELEC to (i) **INFORM** the Tribunal and the parties of the schedule of the aforesaid decryption and (ii) **ALLOW** the Tribunal's representative and the parties to observe and comment during the decryption; and

(e) **NOTE** and **GRANT** the Letter dated October 28, 2016 of Hon. Marcelino K. Wacas, Executive Judge, Regional Trial Court, Branch 25, Bulanao, Tabuk City, Kalinga, requesting that the COMELEC Election Records and Statistics Department be allowed to decrypt the SD cards and print election returns and ballot images in the protested precincts pursuant to COMELEC Resolution No. 10154 which are needed for the actual revision of ballots relative to Election Protest No. 44 (Karl Pimentel Baac vs. Marcelo V. Dela Cruz, Jr.) for the position of Mayor, Municipality of Rizal, Kalinga Province, which involves all the twenty two (22) clustered precincts of the said Municipality."
