NOTICE OF DECRYPTION OF SECURE DIGITAL CARDS

Pursuant to *Resolution No. 17-214* dated November 23, 2017, confirming the *Order of the Tribunal* dated November 8, 2017, the decryption of the Secure Digital (SD) cards in the fifty-eight (58) protested clustered precincts in the instant case is scheduled to commence on December 6, 2017, 9:00 A.M., at the office of the Commission on Elections (Comelec), Intramuros, Manila, which shall continue until completion.
