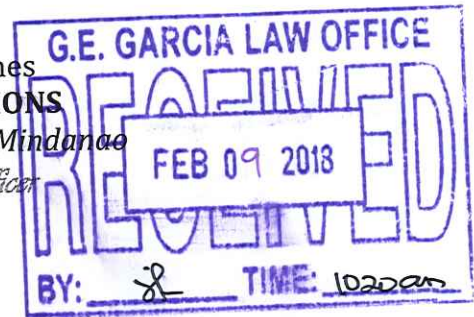

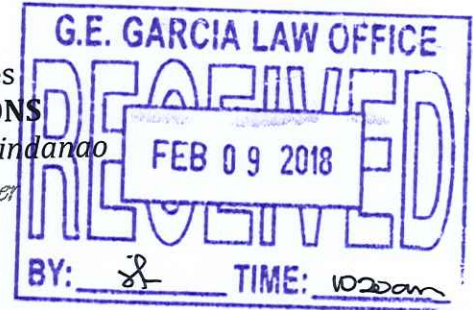

## ORDER
