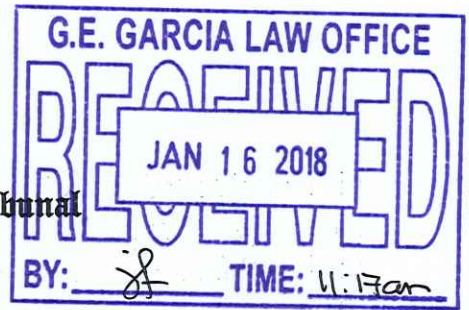

NOTICE OF DECRYPTION
