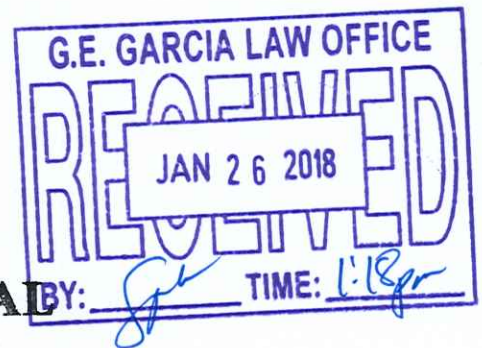

NOTICE OF DECRYPTION

Pursuant to Resolution No. 16-89 dated 17 January 2018, notice is hereby given that the decryption of the Secure Digital (SD) cards pertaining to the Five Hundred Ninety-Seven (597) pilot precincts of Protestant Tolentino is scheduled to commence on **05 February 2018 at 9:00 o'clock in the morning**, at the Project Management Office of the Commission on Elections, Palacio del Gobernador Bldg., Intramuros, Manila and shall continue until completion.

Protestant Tolentino is directed to remit directly to the COMELEC not later than **31 January 2018** the amount of **Php348,575.00** as specified in the attached Order of Payment, and furnish a copy of compliance to the Tribunal. For the printing of the picture images, Protestant Tolentino is further directed to provide the supplies identified by the COMELEC in the attached list.

Both parties are directed to send their representatives to witness the aforesaid decryption and printing. However, the absence of party representatives will not preclude the COMELEC from undertaking these activities.
