**ORDER**

Finding the Motion to Conduct Technical Examination (of the Voters' SIGNATURES and THUMBMARKS Appearing on the EDCVL and VRRs in the Pilot Protested Clustered Precincts) filed by the protestant on April 12, 2018 to be in order, the Commission (Second Division) hereby **GRANTS** the same.

The records reveal that the protestant included in the prayer of the protest the *technical examination of the signatures and thumbmarks appearing in the Voter Registration Record (VRR), Book of Voters and the EDCVL in all the Protested Clustered Precincts of all the Municipalities of Basilan, Tawi-Tawi, Maguindanao and Lanao del Sur.*<sup>1</sup> The same prayer was likewise expressed in the Protestant's Preliminary Conference Brief when he moved for the *referral of the protest to signatures and thumbmark experts for the technical examination and comparison of the signatures and thumbmarks as appearing in the VRRs and in the EDCVL.*<sup>2</sup> The Commission (Second Division) then noted the manifestation in the Preliminary Conference Order.<sup>3</sup>

The Commission finds that it would be within the interest of the electorate of the Autonomous Region of Muslim Mindanao (ARMM) to allow the technical examination of the voting and election records to determine if there was massive substitution of voters as alleged by the protestant. The same shall aid the Commission (Second Division) in the determination of substantial recovery in the pilot protested precincts. Undeniably, the conduct of the technical examination is a reasonable, efficient and expeditious means to determine the truth or falsity of the allegation.

**ACCORDINGLY,** the Election Records and Statistics Department (ERSD) of this Commission is hereby directed to conduct the technical examination of the Election Day Computerized Voters List (EDCVL) and Voter's Registration Records (VRR) in the 167 pilot protested precincts relative to the instant case herein enumerated and indicated in the subject *Motion* :

The Director IV of the ERSD shall make all the necessary steps to ensure the smooth and prompt conduct of the proceedings until its completion, in accordance with Comelec Resolution No. 10200 (*The*



*Uniform Procedure and Payment of Fees on the Technical Examination of Election Documents Related to Election Protest Cases filed before the Commission on Elections).*
