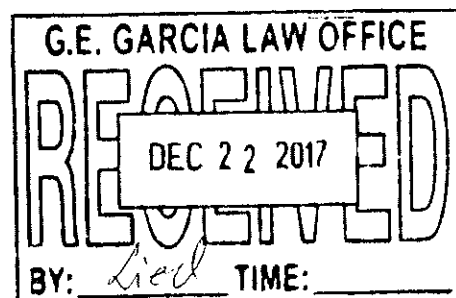

Sirs/Mesdames:

*Please take notice that the Tribunal issued a Resolution dated **DECEMBER 5, 2017**, which reads as follows:*

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to **NOTE** the Reply (to the Strong Comment/Opposition [on/to the Urgent *Ex-Parte* Motion to be Allowed to Secure Soft Copies of the Ballot Images and Other Reports from the Decrypted Secured Digital Cards] dated November 6, 2017), dated November 24, 2017 filed by counsel for protestee Maria Leonor G. Robredo, reiterating her previous request that she be allowed to secure the soft copies of the ballot images, election returns and other reports from the decrypted Secure Digital cards from the Provinces of Camarines Sur, Iloilo and Negros Oriental, without additional costs to protestant Ferdinand R. Marcos, Jr.

Acting on the Report dated December 4, 2017 of the Exploratory Mission/Retrieval Team, Presidential Electoral Tribunal (PET), re: Exploratory Mission Report, the Tribunal Resolved to

(a) **AUTHORIZE** the travel to Camarines Sur on January 22, 2018 of the PET Retrieval Team, composed of the following personnel, to commence the collection of ballot boxes and their contents with their keys, if with locks; voter’s receipts (if not included inside or with the ballot boxes); list of voters, particularly the Election Day Computerized Voter’s List (EDCVL); voters registration records (VRRs); and book of voters from the 1,813 clustered precincts in the Province of Camarines Sur:

The PET Retrieval Team shall be billeted at the Villa del Rey Hotel if the hotel is available on the period of retrieval, otherwise, the CBD Plaza Hotel will serve as an alternate.

(b) **DIRECT** all City and Municipal Treasurers and Election Officers to **DELIVER** to the PET Retrieval Team at the designated staging area/hub at the Camarines Sur Convention Center, Capitol Complex, Cadlan, Pili, Camarines Sur, or if the Convention Center is not available, at the Freedom Sports Complex of the Department of Education, Region V, Division of Camarines Sur, all the ballot boxes and their contents with their keys, if with locks; voter's receipts (if not included inside or with the ballot boxes); list of voters, particularly the EDCVL; VRRs; and book of voters and other election documents and paraphernalia used in the 2016 National and Local Elections, regardless of the pendency of any election protest or election related case before the House of Representatives Election Tribunal, Senate Electoral Tribunal, Commission on Elections or any trial court, based on the schedule below:

(c) **DIRECT** the Regional Trial Court judges before whom any election protest involving the clustered precincts of the Municipalities of Siruma and Calabanga are pending to **RELEASE** to the PET Retrieval Team in Camarines Sur, under proper receipt and with notice to the parties, the ballot

boxes and their contents with their keys, if with locks; voter's receipts (if not included inside or with the ballot boxes); list of voters, particularly the EDCVL; VRRs; and book of voters and other election documents and paraphernalia used in the 2016 National and Local Elections based on above schedule;

(d) **DIRECT** the Camarines Sur Police Provincial Officer of the Philippine National Police (PNP) and the respective Chiefs of Police of the cities and municipalities of Camarines Sur to **PROVIDE** adequate police security and escort when the ballot boxes and above-enumerated election documents and paraphernalia are transported from the above-mentioned cities and municipalities to the PET Retrieval Team's staging area/hub;


(e) **DIRECT** the Provincial Director of the PNP and the respective Chiefs of Police of the cities and municipalities of Quezon Province, San Pablo, Laguna and Santo Tomas, Batangas to **PROVIDE** adequate police route security and escort or security measures when the convoy of trucks carrying the ballot boxes and above-enumerated election documents and paraphernalia enters into and passes by their respective areas of jurisdiction in going to Manila from the Province of Camarines Sur;

(f) **DESIGNATE** the Philippine Postal Corporation (PHILPOST) as the official carrier for transporting, on a door-to-door basis, the ballot boxes and above-enumerated election documents and paraphernalia from Camarines Sur to the Supreme Court-Court of Appeals Gymnasium, Supreme Court Compound, Ermita, Manila;

(g) **AUTHORIZE** Atty. Felipa B. Anama, Clerk of the Tribunal, to enter into a contract of carriage with PHILPOST in connection with the above delivery; and

(h) **GRANT** the PET Retrieval Team the following estimated amounts for the subject retrieval, to be charged against the protestant's cash deposit:


