“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved, upon the recommendation of Atty. Linuel G. Alindogan, Head of the Retrieval Team, to

(a) **AUTHORIZE** Joselito Dominguiano to accompany and be part of the Exploratory Mission Team to the Provinces of Iloilo and Negros Oriental as Alternate Security Officer; and


