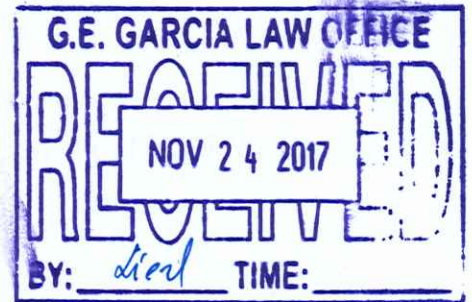

IN THE MATTER OF THE MANIFESTATION AND MOTION TO DIRECT THE ELECTION OFFICER OF CARAMOAN, CAMARINES SUR TO CANCEL THE SCHEDULED VERIFICATION OF SIGNATURES AND THUMBMARKS FILED BY MAYOR MARLYN S. CORDIAL IN E.M. 17-005 (RCL) ENTITLED: "IN THE MATTER OF THE PETITION FOR RECALL AGAINST MAYOR MARLYN S. CORDIAL AS MUNICIPAL MAYOR OF CARAMOAN, CAMARINES SUR"

Brillantes, Jr., counsel for the Movant.

The Prayer of the Manifestation and Motion reads:

WHEREFORE, premises considered, the movant most respectfully prays of the Hon. Commission that this Motion be granted and that the Acting Election Officer of Caramoan be directed to cancel and stop the November 20-25, 2017 scheduled verification of the signatures and thumbmarks of the petitioners in the instant recall Petition until after the resolution by the Hon. Commission of the pending Motion for Reconsideration and until after the Presidential Electoral Tribunal has granted the request of the Hon. Commission for the temporary custody and use of the lists of voters, such as the EDCVLs and the VRRs.

The movant prays for such other relief just and equitable under the premises."

The Commission **RESOLVED**, as it hereby **RESOLVES**, to direct the Election Officer of Caramoan, Camarines Sur to desist from any action on the Petition for Recall until the Motion for Reconsideration (of the Order Finding Sufficiency of the Petition for Recall of Mayor Marlyn S. Cordial of Caramoan, Camarines Sur) in E.M. No. 17-005 (RCL) entitled: "In the Matter of the Petition

for Recall against Mayor Marlyn S. Cordial as Municipal Mayor of Caramoan, Camarines Sur", is ruled upon.
