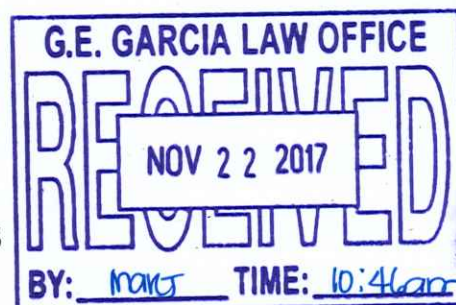

Relative to the *Memorandum* filed on October 27, 2017 by **Ms. Lolita D. Zara**, Identification Officer II, Voters Identification Division (VID), Election Records Statistics Department (ERSD), this Commission in connection with EPC No. 2016-07, entitled "*Ma. Risa Rafols Angana vs. Arlene E. Zambo. et. al*"; the undersigned hereby recommends the following directives:

1. *Mr. Marcelo T. Mendez*, Ballot Box Custodian II, Electoral Contests Adjudication Department (ECAD), this Commission, to facilitate the retrieval of the documents (Book of Voters and Election Day Computerized Voters List) utilized during the conduct of Technical Examination from the Voters Identification Division, Election Records and Statistics Department (ERSD) and to deposit the same to Comelec Philpost Warehouse for safekeeping on November 24, 2017 at 10:00 o'clock in the morning;
2. The *Head of the Police Security and Protection Group (PSPG)* and *Head of the Comelec Organic Security Force (COSF)* to assign two (2) personnel each to provide security detail during said undertaking and to coordinate with Mr. Marcelo Mendez regarding the retrieval and transportation of the above-mentioned documents scheduled on November 24, 2017; and
3. *Engr. J. Thaddeus P. Hernan*, Director IV, Administrative Services Department to provide one (1) vehicle and assigned driver to transport the said documents from the Voters Identification Division, Elections Records Statistics

Philpost Warehouse and to coordinate with Mr. Marcelo Mendez regarding the retrieval and transportation of the above-mentioned documents scheduled on November 24, 2017; and

4. The respective parties to send their representatives in order to observe said proceeding and to be present at exactly 10:00 a.m., November 24, 2017 at the Voters Identification Division, Elections Records Statistics Department (ERSD).
