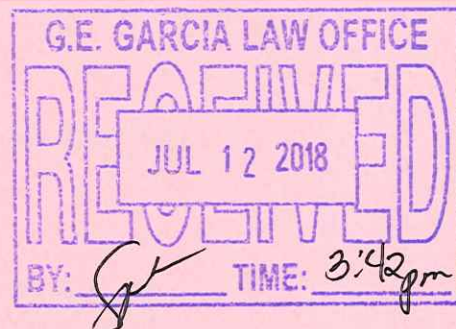

Please take notice that the Tribunal issued a Resolution dated JULY 10, 2018, which reads as follows:

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- Acting on the following Incident Reports relative to the ongoing revision of ballots, the Tribunal Resolved to

(i) **NOTE** the Incident Report dated June 29, 2018 re: Clustered Precinct No. 28 (Precincts 0052A, 0052B and 0053B), Brgy. Tapi-An, Municipality of Batad, Iloilo, at Table No. 1, which reads ‘No MOV, no ER for Table 1 (HR: Eleanor C. Consuegra) – Ballot box has no MOV on the day of the election; Only the test MOV dated May 6, 2016 has been placed inside the ballot box; ER were also not found inside the box’; and **DIRECT** the Revision Committee to **CONTINUE** with the revision and **NOTE** the above-quoted observations in their Revision Report;

(v) **NOTE** the Incident Report dated June 26, 2018 re: Clustered Precinct No. 31 (Precincts 61A, 61B, 62A and 62B), Brgy. Quiasan, Municipality of Balasan, Iloilo, at Table No. 34, which reads 'Chairman Joseph Daniel Duran's signature as appearing on the Minutes is different from the signatures on the ballots. The signatures on the ballots were shorter and had different strokes'; and **DIRECT** the Revision Committee to **CONTINUE** with the revision and **NOTE** the above-quoted observation in their Revision Report;

(vi) **NOTE** the Incident Report dated June 27, 2018 re: Clustered Precinct No. 22 (Precincts 0050A, 0051A and 0052A), Brgy. Puerto Princesa, Municipality of Barotac Viejo, Iloilo, at Table No. 29, which reads 'Wet ballots'; and **APPROVE** the recommendation to 'Suspend revision proceedings; refer to decrypted image';

San Francisco, Municipality of Barotac Viejo, Iloilo, at Table No. 32, which reads 'External condition of ballot box: 5 plastic seals in place but flap without steel wire lock. There is a fist-sized hole and huge crack on the cover (beside the flap). Contents of ballot box: MOV and ER are missing; present are ballots, rejected envelope with ballots, unused ballot envelope with torn unused ballots, black box contained voter's receipts'; **REQUIRE** the Municipal Treasurer of Barotac Viejo, Iloilo, to **EXPLAIN** the

observations in the subject Incident Report within ten (10) days from notice hereof; and **DIRECT** the Revision Committee to **CONTINUE** with the revision and **NOTE** the above-quoted observations in their Revision Report;

(x) **NOTE** the Incident Report dated June 27, 2018 re: Personal Complaint of Alternate Revisor Sally H. Nisola against Protestee Revisor Rogelio Milan; **APPROVE** the recommendation therein; and **DIRECT** all Party Revisors, Head Revisors and Appraisers to **OBSERVE** proper decorum in the revision area; and

(xi) **NOTE** the Incident Report dated June 14, 2018, which reads 'One piece of Voter's Verification Receipt (VVR) left under Table No. 7, care of Head Revisor Princess Bometivo, per report of WM2 Romeo B. Agcaoili dated June 14, 2018 stating that such document was found upon conducting initial roving inspection inside the Revision Room yesterday afternoon (June 13, 2018)'; **REQUIRE** Head Revisor Princess Bometivo to **EXPLAIN** (a) why the subject VVR was left under her table and (b) why she should not be removed as Head Revisor because of such negligence, both within ten (10) days from notice hereof.

The Tribunal further Resolved to

(a) **NOTE** the Urgent *Ex-Parte* Motion to Direct Atty. Vic Rodriguez to Disclose the Names of Persons in the Revision Area Who Were Aware of the Use of the Plastic Magnifying Glass, dated July 4, 2018 filed by counsel for protestee Maria Leonor G. Robredo;

(b) **NOTE** the Manifestation and Motion (in Lieu of Comment) dated July 4, 2018 filed by the Solicitor General, as the People's Tribune, in compliance with the resolution dated April 24, 2018, praying, among others, for the Tribunal to affirm its resolution dated April 10, 2018 declaring that it has 'no basis to impose a 25% threshold in determining whether a vote is valid';

(c) **DIRECT** the Commission on Elections (COMELEC) to **FILE** its **OWN COMMENT** on the Urgent Motion for Reconsideration (of the resolution dated April 10, 2018) with Reiterative Prayer to Immediately Direct the Head Revisors to Use the Twenty-Five (25%) Threshold Percentage in the Revision, Recount and Re-Appreciation of Ballots dated April 18, 2018 filed by counsel for protestee Robredo, within a **NON-EXTENDIBLE** period of ten (10) days from notice hereof;

(d) **NOTE** the Letter dated July 4, 2018 of Julius Caezar D. Tumulad, re: Incident Report dated May 23, 2018, 9

in compliance with the resolution dated June 5, 2018, with a **STERN WARNING** that a repetition of the same or similar acts shall be dealt with more severely;

(e) **NOTE** the Letter dated July 4, 2018 of Niño Jefferson J. Regala, re: Incident Report dated May 23, 2018, in compliance with the resolution dated June 5, 2018;

(f) **NOTE** the Letter of Explanation dated July 5, 2018 of Jose Oliver F. Farne, Revisor for the protestee, re: Incident Report dated May 17, 2018, in compliance with the resolution dated June 5, 2018, with a **STERN WARNING** that a repetition of the same or similar acts shall be dealt with more severely;

(g) **NOTE** the Report dated June 26, 2018 of Atty. Linuel G. Alindogan, Court Attorney IV, Office of the Chief Attorney, and Head, PET Retrieval Team, informing the Tribunal that, pursuant to the resolution dated April 24, 2018, the House of Representatives Electoral Tribunal, through Sanny Francis L. Pagalilauan, Legislative Staff Officer V, has submitted the estimated expenses for the delivery to the PET Office at the SC-CA Gym of three hundred sixty-five (365) ballot boxes and bundles of election documents involved in HRET Case No. 16-005 (Villafructe vs. Bordado, Third District, Camarines Sur) in the total amount of One Hundred Forty-Seven Thousand Forty-Three Pesos and 20/100 (₱147,043.20);

(h) **NOTE** the Manifestation of Grave Concern with Extremely Urgent Motion to Investigate (Re: PET Head Revisors and Other PET Personnel Fraternizing with Protestee's Revisor) dated July 9, 2018 filed by counsel for protestant Marcos, Jr., but **DENY** the motion to investigate as the Tribunal has already commenced and concluded its investigation relative to the subject 'Pansol outing';

(i) **NOTE** the Letter dated July 6, 2018 of Nestor D. Borromeo, Revisor for the protestant, in compliance with the resolution dated June 26, 2018, with a **STERN WARNING** that a repetition of the same or similar acts shall be dealt with more severely;

(j) **NOTE WITHOUT ACTION** the Urgent Motion to Direct the Commission on Elections to Immediately File Its Comment on the Urgent Motion for Reconsideration (of the resolution dated April 10, 2018), dated July 9, 2018 filed by counsel for protestee Robredo, in view of letter (c) above; and


(k) **NOTE** the Strong Manifestation with Motion (Re: Use of Decrypted Ballot Images for Revision) dated July 5, 2018 filed by counsel for protestant Marcos, Jr. relative to the

resolutions dated June 5, 19, and 26, 2018 in connection with the judicial revision and recount proceedings for the pilot protested provinces of Camarines Sur and Iloilo, but **DENY** the motion to hold in abeyance the use of decrypted ballot images in the enumerated protested clustered precincts until the issue on the integrity of the said ballot images is first resolved.
