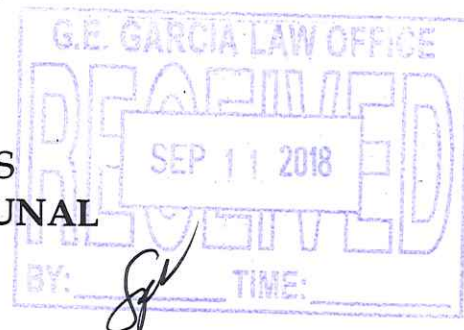

## MANIFESTATION

COMES NOW, the Commission on Elections (COMELEC), through the undersigned counsels of the Law Department, most respectfully manifests:

1. On 08 August 2018, the COMELEC *En Banc*, in its Regular Meeting, promulgated Minute Resolution No. 18-0633<sup>1</sup>, which approved with modification the request of Administrative Services Department Director J. Thaddeus P. Hernan as concurred in by Executive Director Jose M. Tolentino, Jr. for authority to temporarily issue Laptop Computers to the following offices of COMELEC:

2. The request to pull-out of the twenty nine (29) units of laptops will be taken from the unused 2016 CCS Contingency Laptops stored at the COMELEC Warehouse in Sta. Rosa City, Laguna, which are not covered by the Precautionary Protection Order (PPO) issued by this Honorable Tribunal or the Protection Order

3. The intended date of the pull-out of the contingency laptops from the COMELEC Warehouse at Sta. Rosa City, Laguna will be on 14 September 2018 at 10:00 o'clock in the morning.

**18-0633. IN THE MATTER OF THE AUTHORITY TO ISSUE 2016 CCS  
CONTINGENCY LAPTOP COMPUTERS**

This pertains to the Memorandum dated August 6, 2018 of Executive Director Jose M. Tolentino, Jr., relative to the Memorandum of ASD Director J. Thaddeus P. Hernan, requesting authority to issue 2016 CCS Contingency Laptop Computers.

Memorandum of Executive Director Tolentino reads:

*"Forwarded is the Memorandum dated 24 July 2018 of Director J. Thaddeus P. Hernan, Administrative Services Department (ASD), relative the attached IT Resource Issuance Evaluation/Recommendation from the Information Technology Department (ITD), regarding the request of Mr. Antonio G. Murillo, Executive Assistant V, Office of Commissioner Marlon S. Casquejo, for the purchase of Eighteen (18) units Desktop Computers.*

*Due to unavailability of stocks of Desktop Computers at the Property Division, ASD, and the pending procurement thereof, Director Hernan is requesting for authority to temporarily issue Laptop Computers to be taken from the 2016 CCS Contingency Laptops and which are not covered by the Precautionary Protection Order issued by PET/SET to the following offices of the Commissioners with similar requests, to wit:*

1. Office of Comm. Marlon S. Casquejo	18
2. Office of Comm. Socorro B. Inting	3

*The undersigned respectfully recommends approval of the subject request, provided that the PET and the parties involved are notified by the ASD of the time and date of pull-out.*

The Commission **RESOLVED**, as it hereby **RESOLVES**, to **approve with modification** the foregoing request of ASD Director J. Thaddeus P. Hernan as concurred in by Executive Director Jose M. Tolentino, Jr., for **authority** to temporarily issue Laptop Computers to the Offices of Commissioners Socorro B. Inting and Marlon S. Casquejo as to include the



Office of Commissioner Antonio T. Kho, Jr. for eight (8) computers each, to be taken from the 2016 CCS Contingency Laptops and which are not covered by the Precautionary Protection Order issued by PET/SET.

**RESOLVED**, moreover, for purposes of transparency, to **direct** the Administrative Services Department to notify the PET/SET and the parties involved of the time and date of pull-out of said computers.

The Administrative Services Department shall make an inventory of the requirements for laptops of the Offices of the Chairman and Commissioners and for Finance Services Department to ensure funding for such procurement.

Let the Information Technology Department, the Administrative Services Department, the Finance Services Department and the Procurement Management Department implement this Resolution.
