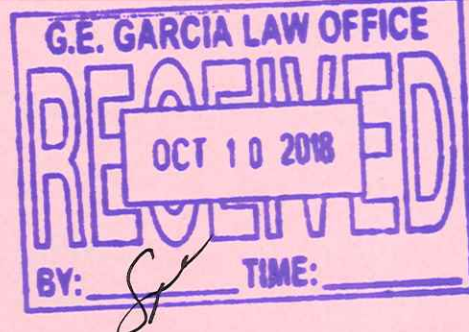

NOTICE

Sirs/Mesdames:

Please take notice that the Tribunal issued a Resolution dated AUGUST 28, 2018, which reads as follows:

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- Acting on the following Incident Reports relative to the on-going revision of ballots, the Tribunal Resolved to

(i) **NOTE** the Incident Report dated July 23, 2018 re: Clustered Precinct No. 3 (Precincts 5A, 6A, 7A and 7B), Brgy. Poblacion, Zone 1, Municipality of Estancia, Iloilo, at Table No. 40, which reads ‘Damp ballots, watermarks unreadable; unable to verify security features’; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Estancia, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above condition of the ballots;

(ii) **NOTE** the Incident Report dated July 27, 2018 re: Clustered Precinct No. 41 (Precincts 0070A and 0071A), Brgy. Passi, Municipality of Igbaras, Iloilo, at Table No. 38, which reads ‘Wet ballots were found at ballot box for precinct in cluster 0070A and 0071 (Passi, Igbaras, Iloilo) supposed to be revised at Table #38’; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Igbaras, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(iii) **NOTE** the Incident Report dated August 7, 2018 re: Clustered Precinct No. 10 (Precincts 26A, 27A and 28A), Brgy. Bankal, Municipality of Lemery, Iloilo, at Table No. 34, which reads ‘Discrepancy in ballot count - The ballot box from Barangay Bankal, Municipality of Lemery, Iloilo (CP No 10 [26A, 27A and 28A]) contains 438 ballots per the actual physical count during the revision proceedings but the MOV indicates that the total number of ballots counted was 439. In addition, only 432 voter’s receipts were found inside the ballot box’; and **DIRECT** the Revision Committee to (i)

CONTINUE with the revision and (ii) **NOTE** the aforequoted observations in their Revision Report;

(iv) **NOTE** the Incident Report dated August 7, 2018 re: Clustered Precinct No. 8 (Precincts 0023A, 0023B, 0025A, 0029A and 0029B), Brgy. Cagamutan Norte, Municipality of Leganes, Iloilo, at Table No. 26, which reads 'The Status Report indicated that only 493 actually voted while the ER and MOV indicated 508 actually voted'; and **DIRECT** the Revision Committee to (i) **CONTINUE** with the revision and (ii) **NOTE** the aforequoted observation in their Revision Report;

(v) **NOTE** the Incident Report dated August 7, 2018 re: Clustered Precinct No. 6 (Precincts 14B, 15A and 15B), Brgy. Buntatala, Municipality of Leganes, Iloilo, at Table No. 34, which reads 'Discrepancy in the ballot count –The ballot box from Brgy. Buntatala, Municipality of Leganes Iloilo (CP No. 6 [14B, 15A & 15B]) contains 385 ballots per the actual physical count during the revision proceedings. Note, however, the discrepancies in the total ballots cast as reflected in the ER-385 ballots, MOV-386 ballots, and status report–only 312 ballots'; and **DIRECT** the Revision Committee to (i) **CONTINUE** with the revision and (ii) **NOTE** the aforequoted observation in their Revision Report;

(vi) **NOTE** the Incident Report dated August 8, 2018 re: Clustered Precinct No. 19 (Precincts 0043B, 0044A and 0044B), Brgy. Gua-An, Municipality of Leganes, Iloilo, at Table No. 26, which reads 'Ballot box for Clustered Precinct No. 19 for Gua-An, Leganes, Iloilo. The ER and MOV indicated 403 ballots. However, upon actual physical count the number of ballots were 404. Moreover, the revisors observed that the signatures on the ballots and on the MOV for the BEI Chairman were not similar'; and **DIRECT** the Revision Committee to (i) **CONTINUE** with the revision and (ii) **NOTE** the aforequoted observations in their Revision Report;

(vii) **NOTE** the Incident Report dated August 7, 2018 re: Clustered Precinct No. 30 (Precincts 71A, 72A, 73A and 73B), Brgy. San Jose Moto, Municipality of Lemery, Iloilo, at Table No. 35, which reads 'Mislabelled Precinct –CP 13 changed to CP 30; The MOV reflects 551 as actually voted with one rejected ballot while the manual physical count showed only 550 ballots'; and **DIRECT** the Revision Committee to (i) **CONTINUE** with the revision and (ii) **NOTE** the aforequoted observations in their Revision Report;

(viii) **NOTE** the Incident Report dated August 8, 2018 re: Clustered Precinct No. 32 (Precincts 0079B, 0080A, 0080B, 0082A and 0082B), Brgy. Napnud, Municipality of Leganes, Iloilo, at Table No. 2, which reads 'Upon opening the

sealed (ballot box), the ballots were damp and wet; with molds. Most of the ballots stucked (*sic*) together and were brittle'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images'; and **REQUIRE** the Municipal Treasurer of Leganes, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(ix) **NOTE** the Incident Report dated August 8, 2018 re: Clustered Precinct No. 29 (Precincts 0073A, 0073B, 0077A and 0077B), Brgy. Nabitasan, Municipality of Leganes, Iloilo, at Table No. 8, which reads 'Upon opening the sealed ballot box, the contents were wet and torn. Revision cannot be conducted since the contents were no longer legible/readable'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Leganes, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(x) **NOTE** the Incident Report dated August 8, 2018 re: Clustered Precinct No. 21 (Precincts 0047A, 0049A, 0050A, 0052A and 0052B), Brgy. Guihaman, Municipality of Leganes, Iloilo, at Table No. 25, which reads 'Upon opening of the said ballot, there was a foul smell and ballots appeared to have been wet with animal urine. Almost all ballots were contaminated and soiled'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Leganes, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xi) **NOTE** the Incident Report dated August 8, 2018 re: Clustered Precinct No. 26 (Precincts 0066A, 0067A, 0068A, 0068B and 0069A), Brgy. Lapayon, Municipality of Leganes, Iloilo, at Table No. 30, which reads 'Upon opening of the ballot box, there was a foul smell and animal feces were found inside. Almost all the ballots were contaminated and wet'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Leganes, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xii) **NOTE** the Incident Report dated August 13, 2018 re: Clustered Precinct No. 92 (Precincts 0171A and 0172A), Brgy. Tu-og, Municipality of Leon, Iloilo, at Table No. 2, which reads 'Wet Ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Leon, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xiii) **NOTE** the Incident Report dated August 16, 2018 re: Clustered Precinct No. 50 (Precinct 0096A), Brgy. 9

Fundacion, Municipality of Miagao, Iloilo, at Table No. 39, which reads 'Wet Ballots; watermarks of ballots not visible anymore'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xiv) **NOTE** the Incident Report dated August 16, 2018 re: Clustered Precinct No. 84 (Precincts No. 152A and 153A), Brgy. Marinoyan, Municipality of Miagao, Iloilo, at Table No. 10, which reads 'Wet and moldy ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xv) **NOTE** the Incident Report dated August 16, 2018 re: Clustered Precinct No. 85 (Precinct 0154A), Brgy. Matalngon, Municipality of Miagao, Iloilo, at Table No. 16, which reads 'Wet ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xvi) **NOTE** the Incident Report dated August 16, 2018 re: Clustered Precinct No. 86 (Precincts 155A and 156A), Brgy. Naclub, Municipality of Miagao, Iloilo, at Table No. 22, which reads 'Wet ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xvii) **NOTE** the Incident Report dated August 16, 2018 re: Clustered Precinct No. 90 (Precinct 161A), Brgy. Narorogan, Municipality of Miagao, Iloilo, at Table No. 40, which reads 'Wet and moldy ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xviii) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 94 (Precinct 166A), Brgy. Onop, Municipality of Miagao, Iloilo, at Table No. 9, which reads 'Wet ballots and all other items found inside the ballot box'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots and other election paraphernalia;

(xix) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 98 (Precincts 0176A, 0177A and 0178A), Brgy. Palaca, Municipality of Miagao, Iloilo, at Table No. 37, which reads 'Wet and spoiled ballots; ballots transferred to picnic baskets c/o custodian because ballot box was allegedly destroyed'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above condition of the ballots and the ballot box;

(xx) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 100 (Precincts 180A and 180B), Brgy. Potrida, Municipality of Miagao, Iloilo, at Table No. 22, which reads 'Wet ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xxi) **NOTE** the Incident Report dated August 16, 2018 re: Clustered Precinct No. 89 (Precincts 0159A and 0160A), Brgy. Narat-an, Municipality of Miagao, Iloilo, at Table No. 5, which reads 'Wet ballots & security features cannot be detected by the ultraviolet lamps'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xxii) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 111 (Precincts 0199A and 0200A), Brgy. Tabunacan, Municipality of Miagao, Iloilo, at Table No. 12, which reads 'Wet and moldy ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions ballots;

(xxiii) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 116 (Precinct 207A), Brgy. Tig-Amaga, Municipality of Miagao, Iloilo, at Table No. 4, which reads 'Wet ballots, ER, MOV'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots, and other election paraphernalia;

(xxiv) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 122 (Precinct 0214A), Brgy. To-og, Municipality of Miagao, Iloilo, at Table No. 8, which reads

'Wet ballots; wet MOV, ER & VRs; not legible'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots and other election paraphernalia;


(xxv) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 120 (Precincts 211A and 211B), Brgy. Tigmalapad, Municipality of Miagao, Iloilo, at Table No. 27, which reads 'Wet ballots; all contents of the ballot box – wet and moldy'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots and other election paraphernalia;

(xxvi) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 93 (Precinct 0165A), Brgy. Ongyod, Municipality of Miagao, Iloilo, at Table No. 30, which reads 'Wet ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

(xxvii) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 95 (Precinct 0167A), Brgy. Oya-oy, Municipality of Miagao, Iloilo, at Table No. 39, which reads 'Wet and spoiled ballots'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots;

Valencia, Municipality of Miagao, Iloilo, at Table No. 12, which reads 'Wet ballots and accompanying documents'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots and other election paraphernalia; and

(xxix) **NOTE** the Incident Report dated August 17, 2018 re: Clustered Precinct No. 123 (Precinct 215A), Brgy. Tugura-ao, Municipality of Miagao, Iloilo, at Table No. 36, which reads 'Wet ballots (all ballots in box); security features compromised due to moisture'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Miagao, Iloilo, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots.



The Court further Resolved to

(f) **NOTE** the Letter dated August 14, 2018 of Atty. Eduardo V. Bringas, Executive Director, Presidential Anti-Corruption Commission (PACC), Office of the President, transmitting the Letter-Explanation dated July 20, 2018 of Domingo Q. Amata, OIC Municipal Treasurer, Goa, Camarines Sur, which appears to have been erroneously delivered to the PACC Office;

Labrador, Administrative Officer I, City Legal Office, City of Naga, Bicol, returning the resolution dated June 5, 2018 and informing the Tribunal that the City Government of Naga does not have an employee named Trinity Mayor, whom they believe is a private person, and that it has a *Tanggapan ng Sangguniang Panlungsod* Secretariat, headed by the

Secretary to the *Sangguniang Panlungsod*, and not an Office of the Municipal Secretary.” (1a)
