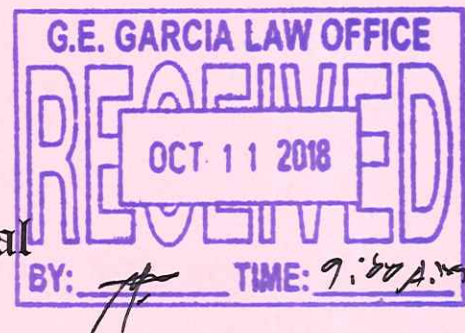

(b) Compliance (with the resolution dated June 19, 2018), dated August 7, 2018 filed by Cinderella F. Ferreras-Lozano, Election Officer IV, Office of the Election Officer, Iriga City, Camarines Sur, transmitting the following:

(i) Letter Explanation of Rosel L. Nagrampa, BEI Chairperson-Clustered Precinct No. 7 (Annex 'A'); and

(ii) Letter Explanation of Hernan N. Malapo, BEI Chairperson-Clustered Precinct No. 22 (Annex 'B');

(c) Letter dated August 1, 2018 of Michael T. Penolio, Municipal Treasurer/Business Permit and Licensing Office (BPLO), Municipality of Tigaon, Camarines Sur, submitting his explanation relative to the Incident Report dated May 30, 2018 re: Clustered Precinct No. 45 (Precincts 0092A, 0093B, 0093C and 0093D), Brgy. Vinagre, Tigaon, Camarines Sur, in compliance with the resolution dated June 19, 2018;

(d) Letter dated August 16, 2018 of Atty. Jose M. Tolentino, Jr., Executive Director, Commission on Elections (COMELEC), stating that the thirty-five thousand (35,000) to forty thousand (40,000) test ballots used by SLI Global Solutions for the 2016 National and Local Elections Automated Election System Review and Certification will be scheduled for disposal in Denver, Colorado on August 31, 2018;



(f) Notice of Withdrawal of Ballot Paper Rolls and Printing of Test Ballots dated August 30, 2018 filed by Atty. Tolentino, Jr., stating that the COMELEC *En Banc*, in its regular *En Banc* meeting August 29, 2018, has approved the withdrawal of sixteen (16) rolls of unused ballot paper intended for the 2016 National and Local Elections for the purpose of printing one hundred fifty-seven thousand three hundred (157,300) test ballots to be used in the on-going quality assurance tests on the enhancements of the Automated Election System for the 2019 National and Local Elections; and
