GREETINGS:

WHEREAS, the revision proceedings in the instant protest is scheduled to take a break on December 24 to 25, 2018, resume on December 26 to 28, 2018 and once more be suspended on December 31, 2018 to January 1, 2019;

WHEREAS, in their Joint Letter dated December 10, 2018, Atty. George Erwin M. Garcia, counsel for protestant Ferdinand 'Bongbong' R. Marcos, Jr., and Atty. Maria Bernadette V. Sardillo, counsel for protestee Maria Leonor 'Leni Daang Matuwid' G. Robredo, requests that the revision proceedings be instead suspended from December 26, 2018 to January 4, 2019 on the ground that some of the parties' representatives and revisors are scheduled to go home to their respective provinces while some would like to take some time to catch up on their paperwork relative to the ongoing revision proceedings;


WHEREAS, the request appears to be meritorious;

WHEREAS, considering the foregoing, the Tribunal directs that the revision proceedings in the instant protest be suspended from December 24, 2018 [not December 26, 2018] to January 4, 2019 to allow the parties' representative/revisors to go home to their provinces for a Christmas vacation and/or catch up on paperwork relative to the instant protest;

NOW, THEREFORE, upon request of the parties, the revision proceedings in the instant protest is hereby **SUSPENDED** from December 24, 2018 to January 4, 2019.
