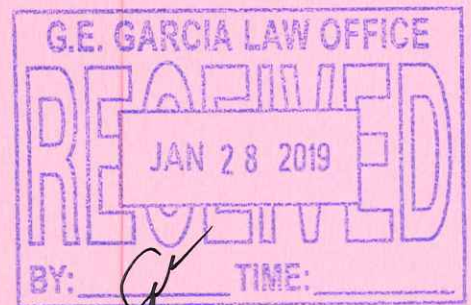

*Please take notice that the Tribunal issued a Resolution dated JANUARY 8, 2019, which reads as follows:*

**“P.E.T. Case No. 005** (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- Acting on the following Incident Reports relative to the on-going revision of ballots, the Tribunal Resolved to

(i) **NOTE** the Incident Report dated November 22, 2018 re: Clustered Precinct No. 34 (Precincts 0033A, 0033B, 0033C, 0033D, 0034A and 0034B), Brgy. Hibaiyo, Guihulngan City, Negros Oriental, at Table No. 29, which reads ‘No ER, no national position result’; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(ii) **NOTE** the Incident Report dated November 22, 2018 re: Clustered Precinct No. 59 (Precincts 0060E, 0060F, 0060G and 0061A), Brgy. Malusay, Guihulngan City, Negros Oriental, at Table No. 27, which reads ‘ER unreadable’; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(iii) **NOTE** the Incident Report dated November 23, 2018 re: Clustered Precinct No. 80 (Precincts 81A, 81B, 81C, 81D and 81E), Brgy. Tinayuhan Hill, Guihulngan City, Negros Oriental, at Table No. 47, which reads ‘No ER. Upon request of certified copy & ER; none was found in the Comelec list’; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(iv) **NOTE** the Incident Report dated November 26, 2018 re: Clustered Precinct No. 27 (Precincts 0048A, 0048B, 0049A and 0049B), Brgy. Panglaya-an, Jimalalud, Negros Oriental, at Table No. 22, which reads ‘Damaged ballots; All of the ballots are torn except for the rejected ballots although MOV and ER are available’; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the



Municipal Treasurer of Jimalalud, Negros Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above condition of the ballots;

(v) **NOTE** the Incident Report dated November 27, 2018 re: Clustered Precinct No. 8 (Precincts 0012B, 0013B and 0014A), Brgy. Bagtic, La Libertad, Negros Oriental, at Table No. 48, which reads 'All of the ballots were not signed by the Chairperson' and **DIRECT** the Revision Committee to **CONTINUE** with the revision of the physical ballots;

(vi) **NOTE** the Incident Report dated November 27, 2018 re: Clustered Precinct No. 26 (Precincts 0047A and 0048A), Brgy. Nasungan, La Libertad, Negros Oriental, at Table No. 49, which reads 'Requested certified true copy of the Election Return is unreadable'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(vii) **NOTE** the Incident Report dated December 3, 2018 re: Clustered Precinct No. 12 (Precincts 24B, 25A, 26A, 27A and 27B), Brgy. Bolisong, Manjuyod, Negros Oriental, at Table No. 45, which reads 'The physical count of official ballots found does not tally with the number of actually voted based on the election returns. Further, there are half torn ballots found with BEI signature and votes'; and **DIRECT** the Revision Committee to (1) **CONTINUE** with the revision of the physical ballots and (2) **REFLECT** in their Revision Report the discrepancy in the physical ballots *vis-à-vis* the data in the election return;

(viii) **NOTE** the Incident Report dated December 4, 2018 re: Clustered Precinct No. 2 (Precincts 0001C, 0003A, 0004A, 0004C, 0005B, 0012A and 0014B), Brgy. Poblacion, Pamplona, Negros Oriental, at Table No. 32, which reads 'Unreadable certified true copy of election returns from PET'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(ix) **NOTE** the Incident Report dated December 6, 2018 re: Clustered Precinct No. 22 (Precincts 64A, 65A, 65B, 66A and 67A), Brgy. Tapon Norte, San Jose, Negros Oriental, at Table No. 38, which reads 'ER unreadable'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(x) **NOTE** the Incident Report dated December 7, 2018 re: Clustered Precinct No. 3 (Precincts 4B, 5A, 5B and 6A), Brgy. Poblacion, Sta. Catalina, Negros Oriental, at Table



No. 45, which reads 'ER unreadable'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(xi) **NOTE** the Incident Report dated December 10, 2018 re: Clustered Precinct No. 17 (Precincts 0040A, 0041A, 0042A and 0042B), Brgy. Buenavista, Santa Catalina, Negros Oriental, at Table No. 43, which reads 'certified true copy of Election Return is unreadable'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(xii) **NOTE** the Incident Report dated December 10, 2018 re: Clustered Precinct No. 57 (Precincts 0123B, 0124B and 0126A), Brgy. San Miguel, Sta. Catalina, Negros Oriental, at Table No. 49, which reads 'wet ballots; damaged ballots; water inside box (water- 2 inches)'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the Municipal Treasurer of Sta. Catalina, Negros Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above condition of the ballots;

(xiii) **NOTE** the Incident Report dated December 11, 2018 re: Clustered Precinct No. 62 (Precincts 0136A, 0137A and 0137B), Brgy. Talalak, Sta. Catalina, Negros Oriental, at Table No. 14, which reads 'no national position result'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(xiv) **NOTE** the Incident Report dated December 11, 2018 re: Clustered Precinct No. 10 (Precincts 0017A, 0017B and 0018A), Brgy. Albiga, Siaton, Negros Oriental, at Table No. 29, which reads 'Missing ER, no actual printed'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(xv) **NOTE** the Incident Report dated December 14 2018 re: Clustered Precinct No. 26 (Precincts 56A, 56B, 57A and 59A), Brgy. Looc, Sibuyan, Negros Oriental, at Table No. 36, which reads 'No national position result'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(xvi) **NOTE** the Incident Report dated December 17, 2018 re: Clustered Precinct No. 18 (Precincts 47A, 47B, 48A and 48B), Brgy. Poblacion 8, Tanjay City, Negros Oriental, at Table No. 23, which reads 'wet ballots; contents of ballot box



are wet and spoiled'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the City Treasurer of Tanjay City, Negros Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above condition of the ballots;

(xvii) **NOTE** the Incident Report dated December 17 2018 re: Clustered Precinct No. 14 (Precincts 38A, 38B, 39A and 39B), Brgy. Poblacion 6, Tanjay City, Negros Oriental, at Table No. 4, which reads 'Ballots are wet, damaged and soiled; contents of ballot box are absolutely unreadable'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the City Treasurer of Tanjay City, Negros Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above condition of the ballots;

(xviii) **NOTE** the Incident Report dated December 18 2018 re: Clustered Precinct No. 42 (Precincts 94A, 94B, 95A and 95B), Brgy. Tubtubon, Sibulan, Negros Oriental, at Table No. 27, which reads 'Certified true copy of ER unreadable as to votes for Robredo'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(xix) **NOTE** the Incident Report dated December 18, 2018 re: Clustered Precinct No. 17 (Precincts 45A, 45B, 46A and 46B), Brgy. Poblacion VIII (Barangay 8), Tanjay City, Negros Oriental, at Table No. 11, which reads 'wet ballots; moisture has caused the security watermarks of affected ballots to smudge; crack on ballot box'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the City Treasurer of Tanjay City, Negros Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots and ballot box;

(xx) **NOTE** the Incident Report dated December 18, 2018 re: Clustered Precinct No. 26 (Precincts 62A, 65A, 65B and 66A), Brgy. Bahi-an, Tanjay City, Negros Oriental, at Table No. 15, which reads 'No ER, Certified true copy of ER not readable as to votes for protestant & protestee'; and **DIRECT** the Revision Committee to (1) **RETRIEVE** the decrypted election returns and (2) **CONTINUE** thereafter the revision using the decrypted election returns;

(xxi) **NOTE** the Incident Report dated December 18, 2018 re: Clustered Precinct No. 35 (Precincts 85A, 85B, 86A, 86B and 89B), Brgy. Novallas, Tanjay City, Negros Oriental, at Table No. 10, which reads 'wet ballots; moisture on wet ballots has caused security watermarks to smudge'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the City Treasurer of Tanjay City, Negros



Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above condition of the ballots;

(xxii) **NOTE** the Incident Report dated December 18, 2018 re: Clustered Precinct No. 11 (Precincts 30A, 31A and 31B), Brgy. Poblacion V, Barangay V, Tanjay City, Negros Oriental, at Table No. 12, which reads 'Ballots have yellowed and clumped together due to water; cracks present on ballot box'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the City Treasurer of Tanjay City, Negros Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots and ballot box;

(xxiii) **NOTE** the Incident Report dated December 19, 2018 re: Clustered Precinct No. 48 (Precincts 0118A, 0118B, 0119A, 0119BB and 0124A), Brgy. San Isidro, Tanjay City, Negros Oriental, at Table No. 27, which reads 'wet ballots; damaged ballots; upon opening the ballot box, the content[s] were wet and damaged. The documents contained therein were dark brown and unusable'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the City Treasurer of Tanjay City, Negros Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above condition of the ballots; and

(xxiv) **NOTE** the Incident Report dated December 19, 2018 re: Clustered Precinct No. 51 (Precincts 125A, 125B, 126A and 127A), Brgy. San Isidro, Tanjay City, Negros Oriental, at Table No. 47, which reads 'wet ballots; damaged ballots; upon opening the ballot box the contents were brown in color, water damaged and unusable'; **DIRECT** the Revision Committee to **REVISE** the decrypted ballot images; and **REQUIRE** the City Treasurer of Tanjay City, Negros Oriental, to **EXPLAIN**, within ten (10) days from notice hereof, the above conditions of the ballots and ballot box.
