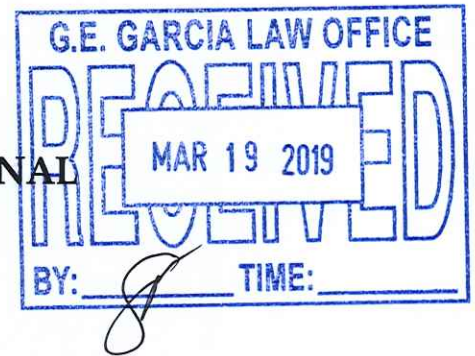

## COMPLIANCE

**COMES NOW**, the Commission on Elections (COMELEC), through the undersigned counsels of the Law Department, and unto this Honorable Tribunal, most respectfully states:

1. On 06 March 2019, the COMELEC, through the Office of the Clerk of the Commission and Law Department, received the Notice of Resolution dated 12 February 2019 of the Honorable Presidential Electoral Tribunal, which pertinently provides:

xxx

(ii) **NOTE** the Incident Report dated January 28, 2019 re: Clustered Precinct No. 34 (Precincts 0073A, 0073B and 0074A), Brgy. Niño Jesus, Bato, Camarines Sur, at Table No. 1, which reads 'No decrypted ballot images for CP34 were found inside the box of decrypted images; only audit log was printed for CP34'; and **DIRECT** the Commission on Elections (COMELEC) to (1) **EXPLAIN** why no ballot images were found in the box and (2) **IMMEDIATELY PROVIDE** the Tribunal with the same, if available, both within ten (10) days from notice hereof;

(iii) **NOTE** the Incident Report dated January 31, 2019 re: Clustered Precinct No. 13 (Precincts 28A, 28B, 29A and 29B), Brgy. Haring, Canaman, Camarines Sur, at Table No. 23, which reads 'Revision Suspended; The bundle contains only the audit log; no ballot images'; and **DIRECT** the COMELEC to (1) **EXPLAIN** why no ballot images were found in the box and (2) **IMMEDIATELY PROVIDE** the Tribunal with the same, if available, both within ten (10) days from notice hereof; and

(iv) **NOTE** the Incident Report dated January 31, 2019 re: Clustered Precinct No. 27 (Precincts 59A and 60A), Brgy. Cubay, San Joaquin, Iloilo, at Table No. 38, which reads 'No ballot images; audit log only'; and **DIRECT** the COMELEC to (1) **EXPLAIN** why no ballot images were found in the box and (2) **IMMEDIATELY PROVIDE** the Tribunal with the same, if available, both within ten (10) days from notice hereof;

2. In compliance thereto, we respectfully submit the Memorandum dated 11 March 2019 from Dir. Ester L. Villaflor-Roxas, Director IV, Election Records and Statistics Department (ERSD), COMELEC, hereto attached as Annex "A" and made an integral part hereof.

### **PRAYER**

**WHEREFORE**, premises considered, the Commission on Elections prays that this **SUBMISSION BE NOTED** and **DEEMED SATISFACTORY COMPLIANCE** with the Order of the Honorable Presidential Electoral Tribunal.

Other reliefs just and equitable under the premises are likewise most respectfully prayed for.





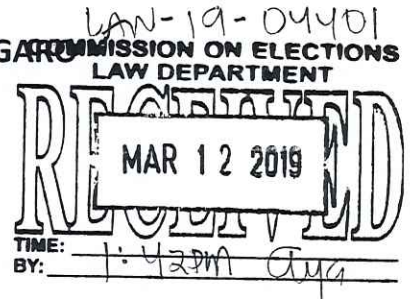

This refers to the Resolution dated February 12, 2019 of the Presidential Electoral Tribunal in PET Case No. 005 (Ferdinand 'Bongbong' R. Marcos, Jr. vs. Maria Leonor 'Leni Daang Matuwid' G. Robredo) directing the COMELEC to (1) Explain why no ballot images were found in the box and (2) Immediately provide the Tribunal with the same if available, both within ten (10) days from notice hereof, for the following areas:

1. Clustered Precinct No. 34 (Precincts 0073A, 0073B and 0074A), Brgy. Nino Jesus, Bato, Camarines Sur;
2. Clustered Precinct No. 13 (Precincts 28A, 28B, 29A and 29B), Brgy. Haring, Canaman, Camarines Sur; and
3. Clustered Precinct No. 27 (Precincts 59A and 60A), Bgy. Cubay, San Joaquin, Iloilo.

During the decryption, it was verified in the audit logs that the BEIs concerned for the above-stated areas, performed the "REZERO" function, which means that except for the audit logs, all the reports and ballots were wiped out.
