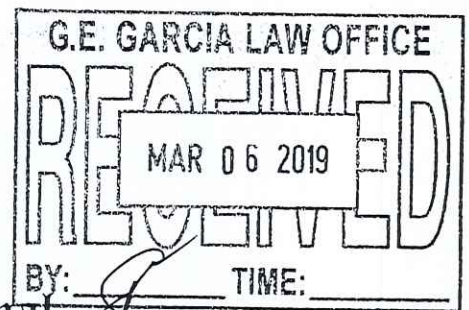

Sirs/Mesdames:

Please take notice that the Tribunal issued a Resolution dated FEBRUARY 12, 2019, which reads as follows:

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- Acting on the following Incident Reports relative to the ongoing revision of ballots, the Tribunal Resolved to

(i) **NOTE** the Incident Report dated January 28, 2019 relative to the (1) Incident Reports dated (a) August 16, 2018 re: Clustered Precinct No. 70 and (b) August 16, 2018 re: Clustered Precinct No. 69 and (2) Revision Report dated January 16, 2019 re: Clustered Precinct No. 70;

(ii) **NOTE** the Incident Report dated January 28, 2019 re: Clustered Precinct No. 34 (Precincts 0073A, 0073B and 0074A), Brgy. Niño Jesus, Bato, Camarines Sur, at Table No. 1, which reads ‘No decrypted ballot images for CP34 were found inside the box of decrypted images; only audit log was printed for CP34’; and **DIRECT** the Commission on Elections (COMELEC) to (1) **EXPLAIN** why no ballot images were found in the box and (2) **IMMEDIATELY PROVIDE** the Tribunal with the same, if available, both within ten (10) days from notice hereof;

(iii) **NOTE** the Incident Report dated January 31, 2019 re: Clustered Precinct No. 13 (Precincts 28A, 28B, 29A and 29B), Brgy. Haring, Canaman, Camarines Sur, at Table No. 23, which reads ‘Revision Suspended; The bundle contains only the audit log; no ballot images’; and **DIRECT** the COMELEC to (1) **EXPLAIN** why no ballot images were found in the box and (2) **IMMEDIATELY PROVIDE** the Tribunal with the same, if available, both within ten (10) days from notice hereof; and

(iv) **NOTE** the Incident Report dated January 31, 2019 re: Clustered Precinct No. 27 (Precincts 59A and 60A), Brgy. Cubay, San Joaquin, Iloilo, at Table No. 38, which reads ‘No ballot images; audit log only’; and **DIRECT** the COMELEC to (1) **EXPLAIN** why no ballot images were found in the box and (2) **IMMEDIATELY PROVIDE** the Tribunal

with the same, if available, both within ten (10) days from notice hereof.

The Tribunal further Resolved to

(a) **NOTE** the Manifestation (in Lieu of a Comment on Protestant Marcos' Extremely Urgent Manifestation of Grave Concern with Omnibus Motion) dated February 5, 2019 filed by counsel for the COMELEC in compliance with the resolution dated January 8, 2019;

(b) **NOTE** the Letter-Explanation dated December 14, 2018 filed by Margarita O. Borromeo, OIC City Treasurer, City of Bais, Negros Oriental, in compliance with the resolution dated November 13, 2018, relative to the Incident Report dated October 29, 2018 re: Clustered Precinct No. 55 (Precincts 0121A, 0121B and 0121C), Brgy. Mansangaban, Bais City, Negros Oriental;

(c) **NOTE** the Letter dated February 8, 2019 of Atty. Maria Bernadette V. Sardillo, counsel for protestee Maria Leonor G. Robredo, stating that they have been informed that the revision, recount and re-appreciation of ballots in the last remaining protested precincts will soon be completed, and **GRANT** her request to terminate the photocopying of stray ballots as soon as the said revision, recount and re-appreciation are completed to avoid any further costs to their client;

(d) **NOTE** the Affidavit dated January 15, 2019 filed by Ma. Vicenta P. Acabal, Municipal Treasurer, Manjuyod, Negros Oriental, in compliance with the resolution dated October 9, 2018, relative to (1) Clustered Precinct No. 1 (Precincts 1A, 2A and 2B), Brgy. Poblacion, Guihulngan, Negros Oriental and (2) Clustered Precinct No. 8 (Precincts 17A, 17B, 18A and 18B), Brgy. Apo Island, Dauin, Negros Oriental;

(e) **NOTE** the Verified Letter of Explanation dated January 17, 2019 filed by Dario L. Arbolado, Acting Municipal Treasurer, LGU-Siaton, Negros Oriental, in compliance with the resolution dated October 9, 2018, relative to the six (6) ballot boxes which were already wrecked/damaged when they were delivered to the PET Retrieval Team;

(f) **NOTE** the Letter-Explanation filed by Rosemarie Tacadao, Municipal Treasurer, Tubungan, Iloilo, in compliance with the resolution dated October 9, 2018, relative to the Incident Report dated September 25, 2018 re: Clustered Precinct No. 13 (Precinct No. 0020A), Brgy. Bantayanan, Tubungan, Iloilo;

(g) **NOTE** the Letter dated January 17, 2019 of Judith J. Umadhay, Election Officer III, Office of the Election Officer, COMELEC, Sta. Barbara, Iloilo, forwarding duplicate copies of the Explanation of the Members of the Board of Election Inspectors (BEI) who served in Brgy. Cabugao Norte, Santa Barbara, Iloilo;

(h) **NOTE** the aforesaid Letter-Explanation dated January 15, 2019 filed by Rachel E. Siojo, Chairperson, Nicolas S. Solidarios, Poll Clerk, and Judy J. Leida, Third Member, BEI, Brgy. Cabugao Norte, Santa Barbara, Iloilo, relative to Clustered Precinct No. 33 (Precinct 0083A);


(i) **NOTE** the Letter dated January 18, 2019 filed by Gemma G. Sumalpong, City Treasurer, Bayawan City, Negros Oriental, in compliance with the resolution dated October 9, 2018, relative to the ballot box of Clustered Precinct No. 104 which was damaged;

(j) **NOTE** the Letter dated January 18, 2019 of Imelda C. Añonuevo, Election Officer III, Office of the Election Officer, COMELEC, San Jose, Camarines Sur, submitting the Affidavit-Explanation of the therein enumerated BEIs of San Jose, Camarines Sur in the 2016 National and Local Elections in compliance with the resolution dated October 9, 2018; and

(k) **NOTE** the Manifestation and Compliance (on/with the resolution dated January 8, 2019), dated January 31, 2019 filed by counsel for protestee Robredo, stating that prior to their receipt of the resolution dated January 8, 2019 on January 14, 2018, protestee Robredo filed her Comment and Opposition (on/to the Extremely Urgent Manifestation of Grave Concern with Omnibus Motion dated December 10, 2018) which was noted in the resolution dated January 15, 2019.

The Tribunal further Resolved, upon the recommendation of the PET *Ad Hoc* Committee, to **DESIGNATE** (1) Mary Grace D. Javonitalla as Chief Tabulator, in lieu of Maria Decten J. Montinola and (2) Ms. Montinola as Assistant Tabulator, both under contracts of services for an initial period of six (6) months, effective upon actual assumption to duty, without prejudice to further renewal, if necessary."
