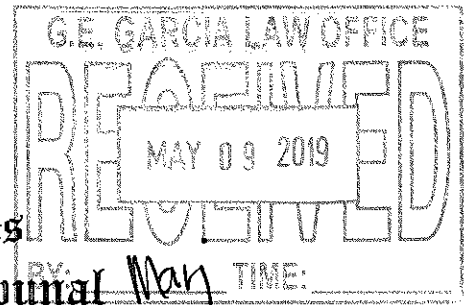

Please take notice that the Tribunal issued a Resolution dated MARCH 5, 2019, which reads as follows:

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to

(a) **NOTE** the Letter dated February 28, 2019 of Atty. George Erwin M. Garcia, counsel for protestant Ferdinand ‘Bongbong’ R. Marcos, Jr., and **GRANT** his request for a copy of the Liquidation Report showing in detail the cost and expenses incurred relative to the revision proceedings for the pilot provinces subject of the instant election protest;

(b) **DIRECT** the PET *Ad Hoc* Committee to **FURNISH** Atty. Garcia with the requested Liquidation Report within ten (10) days from notice hereof;

(c) **NOTE** the Letter-Explanation dated February 15, 2019 filed by Nancy A. Ferrolino, Acting City Treasurer, City of Tanjay, Negros Oriental, in compliance with the resolution dated January 8, 2019 relative to the following Incident Reports (IR):
