*Please take notice that the Tribunal issued a Resolution dated **APRIL 10, 2019**, which reads as follows:*

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to **NOTE** and **GRANT** the Letter dated March 20, 2019 of Bartolome J. Sinocruz, Jr., Deputy Executive Director for Operations, Commission on Elections (COMELEC), seeking approval of the request of Atty. Alvin C. Esmenda, City Treasurer, Taguig City, for authority to transfer two hundred (200) units of Vote Counting Machine bins used in the 2016 Elections, among others, from their current storage area in the Taguig City Hall to another located in C6 Road, Hagonoy, Taguig City.

The Tribunal further Resolved, upon the recommendation of the PET *Ad Hoc* Committee, to

(a) **NOTE** the Report on Revision: Revised Ballot Boxes Containing Wet/Damaged Ballots/Other Election Paraphernalia; and

(b) **CONFIRM** the actions taken on the following ballot boxes upon instruction of the PET *Ad Hoc* Committee-Legal Team in conformity with resolutions on previous incident reports involving wet/damaged ballots/election paraphernalia and in order to speed up the revision proceedings of the ballot boxes/clustered precincts, which are similar in nature, using decrypted images of ballots/elections returns provided by the COMELEC:
