*Please take notice that the Tribunal issued a Resolution dated **MARCH 2, 2021**, which reads as follows:*

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to

(a) **NOTE WITHOUT ACTION**, in view of the Resolution dated November 17, 2020, the Urgent Omnibus Motion ([a] for Investigation; [b] to Treat the OSG Motion for Inhibition as a Mere Scrap of Paper; and [c] Thereafter, to Expunge the OSG Motion for Inhibition from the Records) with Comment (on the OSG Omnibus Motion for Inhibition of Associate Justice Marvic M.V.F. Leonen and Reraffle dated November 9, 2020), dated November 16, 2020 filed by counsel for protestee Maria Leonor G. Robredo;

(b) **NOTE** the Letter dated November 24, 2020 of Justice Marvic M. V. F. Leonen addressed to the Chairperson and Members of the Tribunal, proposing to remove the show cause orders from the *per curiam* Resolution denying his inhibition so that the Tribunal may be in a better position to focus on the merits of the instant protest; and stating that any matter relating to the participation of the Solicitor General in the filing of the Motion for Inhibition may be addressed separately at a much later time upon the Tribunal’s collective discretion; and
