EXPLANATORY NOTE


Roads serve as links of production centers or farms to trade centers or markets. Thus, roads in rural areas encourage the growth of trade and commerce activities which benefit rural folks. Such infrastructure also provide conducive condition for greater mobility of people whether for economic or other purposes.

This is the case with the Pinili-Nueva Era National Road in Pinili town in the province of Ilocos Norte.

Yet the havoc and devastation wrought by Typhoon Maring last September 1992 halted temporarily such mobility and economic activities. This is further aggravated by the destruction of the Pinili-Nueva Era National Road which is very vital to the town's trade and commercial ventures. Most of the National Road's span are badly eroded making it unpassable by vehicle in some parts.

In line with the above pertinent considerations, this bill seeks the construction of embankment protection and concreting of the eroded parts of the Pinili-Nueva Era National Road located in the Municipality of Pinili, Ilocos Norte.

Considering the inadequacy of Ilocos Norte's local government funds to immediately repair and rehabilitate the Pinili-Nueva Era National Road, assistance from the National Government is earnestly requested by the way of approval of this bill.

AN ACT

PROVIDING FOR THE CONSTRUCTION OF ENBANKMENT PROTECTION AND CONCRETING OF THE ERODED PARTS OF THE PINILI-NUUEVA ERA NATIONAL ROAD IN THE MUNICIPALITY OF PINILI, ILOCOS NORTE, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. The Department of Public Works and Highways shall undertake the construction of enbankment protection and concreting eroded parts of the Pinili-Nueva Era National Road located in the Municipality of Pinili, Province of Ilocos Norte.

SEC. 2. The sum of Five Million Pesos or such sum as may be necessary for the implementation of this Act is hereby charged to the appropriations of the Department of Public Works and Highways under the current General Appropriations Act. Thereafter, such sum as may be necessary for its maintenance shall be included in the annual General Appropriations Act.

SEC. 3. This Act shall take effect upon its approval.
