I, Presidentiable **TIBURCIO VILLAMOR MARCOS**, declare to this Honorable Commission, that I am the only legitimate son of former President **FERDINAND EDRALIN MARCOS (ANNEX 1)**.

STATEMENT OF THE CASE

**THIS IS TO PETITION TO CANCEL OR DENY DUE COURSE
THE CERTIFICATE OF CANDIDACY OF RESPONDENT
FERDINAND “BONGBONG” ROMUALDEZ MARCOS, JR.
UNDER SECTION 78 IN RELATION TO SECTION 74, ARTICLE IX
OF THE OMNIBUS ELECTION CODE, AND INVOKING THE
MANDATE OF THE HONORABLE COMMISSION TO ENFORCE
AND ADMINISTER ALL LAWS RELATING TO THE CONDUCT
OF ELECTIONS ON MAY 9, 2022**

ARGUMENTS

1. FERDINAND “BONGBONG” R. MARCOS JR., who claims to be the only legitimate son of **FERDINAND EDRALIN MARCOS**, filed his **CERTIFICATE OF CANDIDACY FOR PRESIDENT** in the COMELEC on October 6, 2021.

2. Based on the GLOBAL AGREEMENT dated January 10, 1980, FERDINAND EDRALIN MARCOS, 10th President of the Philippines, proclaims that “Ferdinand Santiago Trinidad Marcos acclaimed late Ferdinand “Bongbong” Romualdez Marcos and confirmed son Dr. Pacifico Edralin Marcos” is included in the list of Unauthorized Parties including the Acclaimed Members of the Family of Patricia Remedios Santiago Trinidad (acclaimed Imelda Romualdez Marcos), Imee Santiago Trinidad Lacson and Irene Santiago Trinidad Lacson (refer to ANNEX).

With reference to the **LAST WILL AND TESTAMENT** dated December 20, 1988, **FERDINAND EDRALIN MARCOS** proclaims that **FERDINAND MARCOS Y SANTIAGO**, who is also officially known as **FERDINAND “BONGBONG” ROMUALDEZ MARCOS, JUNIOR**, who is the son of Dr. Pacifico Edralin Marcos, is the duplicate of the original **FERDINAND “BONGBONG” ROMUALDEZ MARCOS, JUNIOR [BONGBONG MARCOS (BBM)]** who died in the year 1975 (ANNEX).

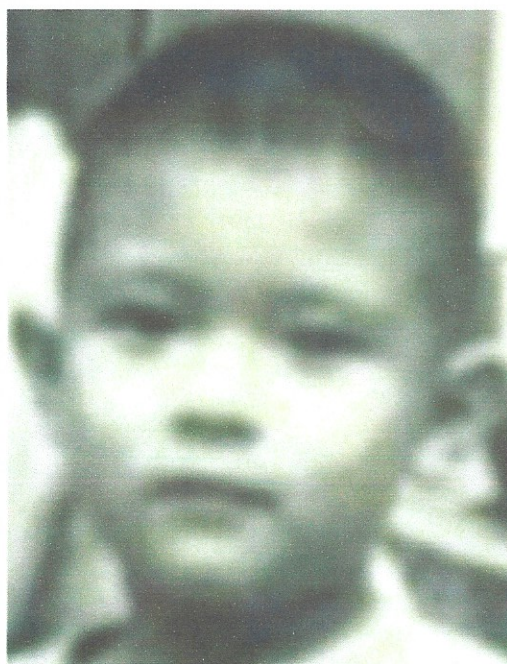
4. **FERDINAND SANTIAGO TRINIDAD MARCOS** is criminally liable for violating the Anti-Alias Law, which refers to Commonwealth Act No. 142 (An Act to Regulate the Use of Aliases), as amended by Republic Act No. 6085, when he misused illegally the legal full name of the deceased, **FERDINAND “BONGBONG” ROMUALDEZ MARCOS, JUNIOR**, through his **CERTIFICATE OF CANDIDACY FOR PRESIDENT** that he filed in the COMELEC on October 6, 2021, to wit:

- “Sec. 1. Except as a pseudonym solely for literary, cinema, television, radio or other entertainment purposes and in athletic events where the use of pseudonym is a normally accepted practice, no person shall use any name different from the one with which he was registered at birth in the office of the local civil registry, or with which he was baptized for the first time, or in case of an alien, with which he was registered in the bureau of immigration upon entry; or such substitute name as may have been authorized by a competent court”.
- “Sec. 2. Any person desiring to use an alias shall apply for authority therefor in proceedings like those legally provided to obtain judicial authority for a change of name”.
- “Sec. 3. No person having been baptized with a name different from that which he was registered at birth in the local civil registry, or in case of an alien, registered in the bureau of immigration upon entry, or any person who obtained judicial authority to use an alias, or who uses a pseudonym, shall represent himself in any public or private transaction or shall sign or execute any public or private document without stating or affixing his real or original name and all names or aliases or pseudonym he is or may have been authorized to use.”
- “Sec. 5. Any violation of this Act shall be punished with imprisonment of from one year to five years and a fine of P5,000 to P10,000.

4.1 With reference to the 1980 GLOBAL AGREEMENT and the 1988 LAST WILL AND TESTAMENT of FERDINAND E. MARCOS, FERDINAND SANTIAGO TRINIDAD MARCOS has usurped the alias, FERDINAND “BONGBONG” ROMUALDEZ MARCOS, JUNIOR, without judicial authority to use the alias or the legal name of the deceased.

4.2 I, who is the only legitimate son of FERDINAND E. MARCOS, have personally knowledge that the original BBM died sometime in 1975 and FERDINAND SANTIAGO TRINIDAD MARCOS has disguised himself as FERDINAND “BONGBONG” ROMUALDEZ MARCOS, JUNIOR for the purpose of perpetuating the Marcos Dynasty under Imelda R. Marcos.

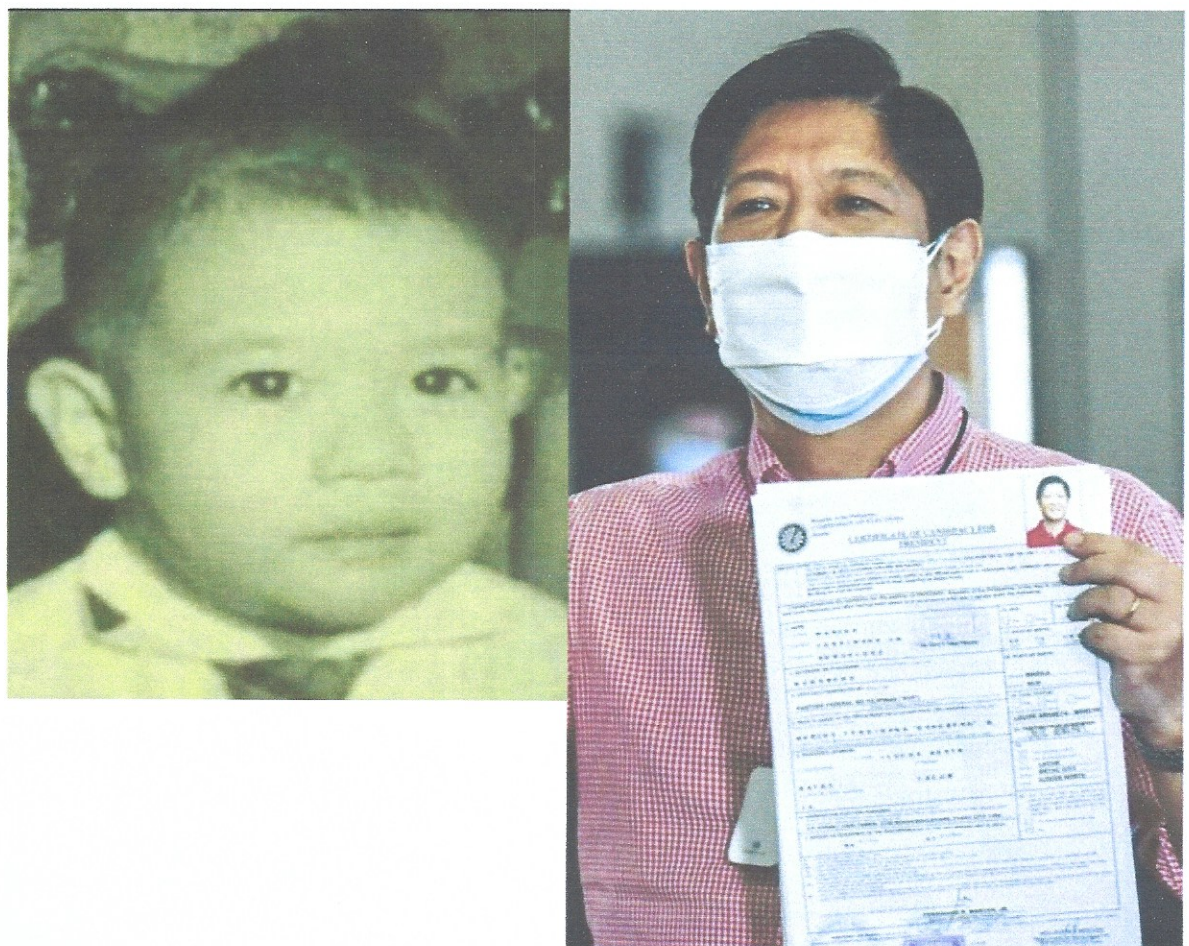

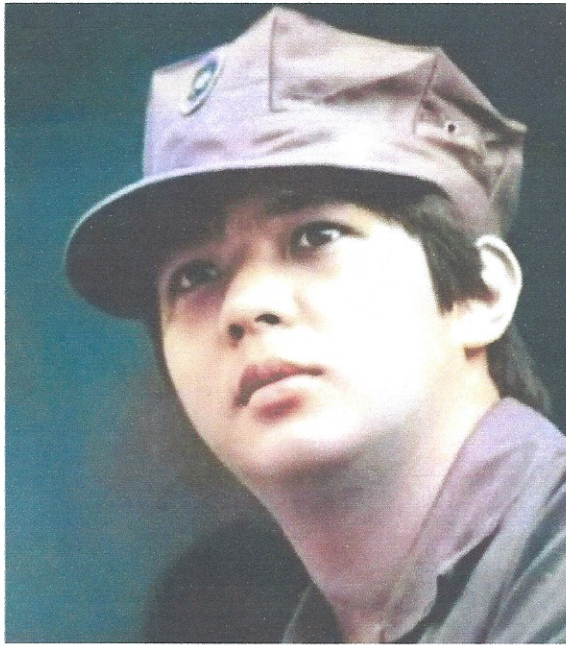
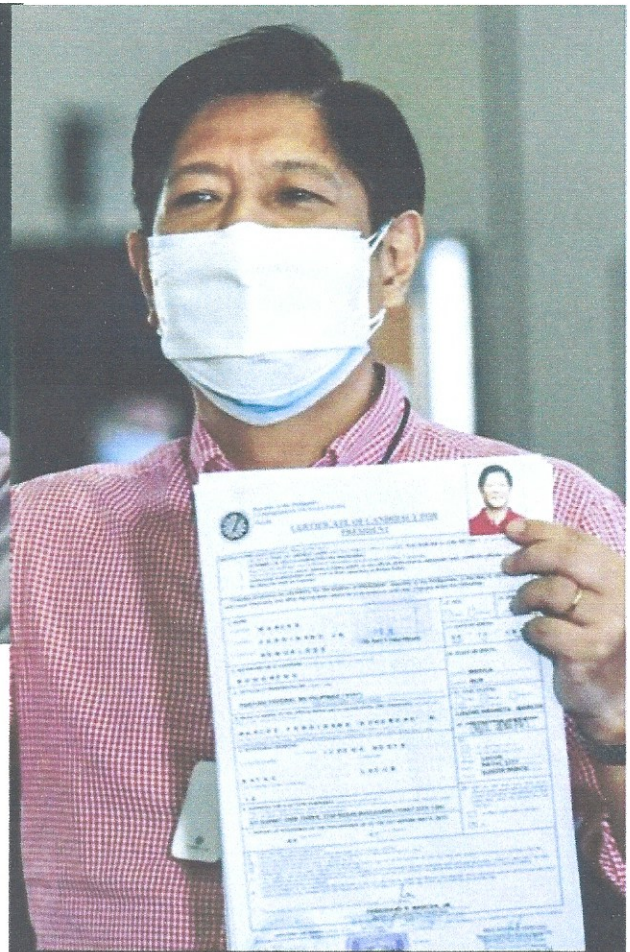

THE IRREFUTABLE PROOF THAT TVM IS THE SUPERPOWER BEHIND THE RENEWAL OF THE VISITING FORCES AGREEMENT (VFA) BETWEEN THE REPUBLIC OF THE PHILIPPINES AND THE UNITED STATES OF AMERICA

President Rodrigo Roa Duterte was hell-bent in abrogating the VFA.

In his online article entitled “DUTERTE’S DECISION TO SCRAP THE VFA: WHIMSICAL OR INSIDIOUS?” and dated February 11, 2020, Renato Cruz de Castro, professor of De La Salle University, Manila, reports that President Duterte has reportedly decided to scrap the 20-year old treaty (VFA).

For de Castro, President Duterte has already ordered his executive secretary to instruct Foreign Secretary Locsin to serve the notice of termination to the United States Government.

President Duterte attempted to wean the Republic of the Philippines away from the United States of America and deliver it into a strategic alignment with the People’s Republic of China before Duterte’s term ends in 2022, informs de Castro.

De Castro reports that rendering the 1951 Mutual Defense Treaty and the 2014 Enhanced Defense Cooperation Agreement is useless is exactly what President Duterte has been seeking since he took office in 2016.

In response to President Duterte’s abrogation of the VFA and inutilizing the 1951 Enhanced Defense Cooperation Agreement, TVM issued officially his **SOVEREIGN ORDER** dated January 11, 2021 to Christopher C. Miller, Acting Secretary of Defense of the United States of America.

The **SOVEREIGN ORDER** of TVM resulted into the official renewal of the VFA, demonstrating that he is indeed the **Star-Star Commander-in-Chief** of the **LSM-ALPHA OMEGA MILITARY PENTAGON**, which is the headquarters of the United States Department of Defense.

Former U.S. President Donald John Trump is not the Commander-in-Chief of the **LSM-ALPHA OMEGA MILITARY PENTAGON**; he did not order Acting Secretary Miller of the U.S. Department of Defense to overrule President Duterte who was hell-bent in terminating the VFA in favor of the People’s Republic of China.

U.S. President Joseph Robinette Biden, Jr. is not the Commander-in-Chief of the **LSM-ALPHA OMEGA MILITARY PENTAGON**; he did not order U.S. Secretary of Defense Lyold Austin III who met personally President Duterte in Malacañang Palace in July 2021 for the official renewal of the TVM in response to the **SOVEREIGN ORDER** of TVM.

- 3) THE PHILIPPINE GOVERNMENT CANNOT EXPROPRIATE TVM'S PRIVATE PROPERTY – THE PHILIPPINE ISLANDS – HIS INDEFEASIBLE-AND-IMPREScriptIBLE ANCESTRAL MOTHER TITLE, OCT T-01-4, IS LEGALLY PROTECTED BY HIS COMPLETE IRREVOCABLE GLOBAL IMMUNITIES.**

In his **NOTICE OF CEASE AND DESIST** dated December 4, 2020, **Andreas Vaagt**, Principal Legal Officer of the General Legal Division of the Office of the Legal Affairs of the United Nations headquartered in New York, United States of America, issued officially his ultimatum to **TVM** because of his alleged unauthorized usage of the name and emblem of the United Nations and his unauthorized affiliation with the United Nations, the rejection of which will result in further appropriate legal action in cooperation with the Permanent Mission of the Republic of the Philippines to the United Nations. **JEC** replied to **Vaagt** through his given email address and that of the said Permanent Mission of the Republic of the Philippines, informing them that **TVM** is the Seven-Star Governor-General of the United Nations, resulting to **Vaagt's** vanishment into thin air (links: bit.ly/2IsgYHx / bit.ly/2Z3UTH6).

In his irrefutable Reply to lawyer Andreas Vaagt, JEC refers to the official **LETTER OF INSTRUCTION NO. 71-C** dated October 4, 1982 and signed by Kurt Waldheim, the Fourth Secretary-General of the United Nations, and approved by Ferdinand Edralin Marcos and confirmed by President Ronald Wilson Reagan, and **TIBURCIO VILLAMOR MARCOS (TVM)**.

ALPHA OMEGA WORLD PEACE COMMUNITY DEVELOPMENT PROGRAM, which is under the World Chairmanship of TVM, has Four Commissions for the United Nations **Project ECOSOC**:
