Please take notice that the Tribunal issued a Resolution dated JULY 13, 2021, which reads as follows:

“P.E.T. Case No. 005 (Ferdinand ‘Bongbong’ R. Marcos, Jr. vs. Maria Leonor ‘Leni Daang Matuwid’ G. Robredo).- The Tribunal Resolved to **NOTE** the Letter dated July 5, 2021 of Executive Director Bartolome J. Sinocruz, Jr., Commission on Elections (COMELEC), with the approval of the COMELEC *En Banc* in its online Regular *En Banc* Meeting on June 16, 2021, giving notice that the personnel of the Warehouse Maintenance Group, Administrative Services Department, COMELEC, will enter/access the Memory Configuration Room at the COMELEC’s Warehouse 1 in Sta. Rosa, Laguna from July 10 to 31, 2021 to perform the following activities:

- (i) Repairs of the detached or sagging metal joist and ceiling boards;
- (ii) Institute physical provisioning to address the requirements of the ‘new normal,’ i.e., makeshift barriers between workstations, etc.;
